WITHDRAWAL ORDER 1944667 - 4674

WHEREAS, the institution was granted recognition namely Shivasharane Hemareddy Mallamma College of Education, Lingasugur, Raichur, Karnataka-584122 run by Shreeshaila Mallikarjuna Education & Rural Development Institution, Raichur District, Eachanal, Karnataka vide SRC (NCTE) order no. F.SRO/NCTE/2007-2008/13834 dt. 31.10.2007 for conducting B.Ed. (Secondary) course of one year' duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 02.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 18.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 for two basic units of 50 students from the academic session 2015-16 with a condition to maintain.

AND WHEREAS, the matter was finally considered before the SRC in its 395th Meeting held on 25th & 26th February 2021 and considered the matter as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply submitted by the institution on 09.02.2021 in response to the Final Show Cause Notice. The Committee found the following deficiency: -

- 1. The institution did not submit a Certified translated English Version Land Document along with Regional Language issued by the Competent Authority.
- 2. The institution has required to submit notarized translated English Version copy of Latest Non – Encumbrance Certificate duly approved by the Competent Authority.
- 3. The total built-up-area of the Building Plan was not readable.
- 4. The FDR of Rs. 4.5 lakhs issued by Vijaya Bank has expired in 16.08.2017.
- 5. Faculty namely Siddappa, Shivaraj, Veeresh and Rambabu have been shown as fresh appointees in the letter dated 22.10.2020 issued by the Registrar, Gulbarga Chiversity and are not possessing NET qualification as required under NCTE Regulations, 2014 (amended vide notification dated 09.06.2017) accordingly not qualified.

Hence, the Committee decided to withdraw the recognition granted to the institution namely, Shivasgarane Hemareddy Mallamma College of Education, Lingasugur, Raichur-584122, Karnataka for conducting B.Ed course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, the Committee decided to withdraw the recognition granted to **Shivasgarane Hemareddy Mallamma College of Education, Lingasugur, Raichur, Karnataka-584122** run by **Shreeshaila Mallikarjuna Education & Rural Development Institute, Raichur District, Karnataka** for conducting **B.Ed. course** of two years duration with an annual intake of 100 students (two basic units) with effect from the next academic session i.e., 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website <u>www.ncte-india.org</u>, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
