WITHDRAWAL ORDER

**WHEREAS**, the recognition was granted to **Thellar College of Education, Tindivanam Road, Thellar, Vandavasi Taluk, Thiruvannamalai District-604406, Tamilnadu** the SRC vide order No. F.SRO/NCTE/B.Ed./2006-2007/9704 dated 23.12.2006 for conducting B.Ed. course of one year duration from the academic session 2006-2007 with an annual intake of 100 students.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 19.01.2015 for its willingness for adherence of provisions of new Regulations.

**AND WHEREAS**, revised provisional recognition order was issued to the institution on 26.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-16.**

**AND WHEREAS**, the matter was finally considered the SRC in its 395<sup>th</sup> meeting held on 25<sup>th</sup> - 26<sup>th</sup> February, 2021 considered the matter and decided as under: -

**"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -**

1. The institution has noted that the institution has not submitted the reply to the grounds mentioned in Final Show Cause Notice issued on 27.02.2020.

Hence, the Committee decided to withdraw the recognition granted to the institution namely, Thellar College of Education, Tindivanam Road, Thellar, Vandavasi Taluk, Thiruvannamalai District-604406, Tamilnadu for conducting B.Ed course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.."


**NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Thellar College of Education, Tindivanam Road, Thellar, Vandavasi Taluk, Thiruvannamalai District-604406, Tamilnadu** run by **Arulmigu Sri Muthalamman Educational Trust, Tiruvannamalai District, Tamilnadu** for conducting B.Ed. programme of two years duration with an annual intake of two basic units of 50 students in each unit w.e.f the next academic session i.e. 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org), with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
