WITHDRAWAL ORDER

WHEREAS, the recognition was granted to Arulmigu Kalasalingam College of Education, Anand Nagar, Krishnankoil, Srivilliputtur Taluk, Virudhunagar District, Tamilnadu-626190 was granted recognition for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students vide SRC, NCTE's vide order no. F.SRO/NCTE/B.Ed./2006-2007/9002 dated 08.11.2006 for the academic session 2006-2007.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 23.01.2015 for its willingness of **2 Units in B.Ed.** course **of 100 students** and adherence of provisions of new Regulations.

AND WHEREAS, revised provisional recognition order was issued to the institution on 05.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-16.

AND WHEREAS, the matter was finally considered by the SRC in its 382nd meeting held on 26th -27th November 2019 and in compliance of the SRC decision a Show Cause Notice was issued to the institution on 03.12.2019 reply received on 26.12.2019.

AND WHEREAS, the matter was placed before the SRC in its 384^{th} meeting held on $12^{th} - 13^{th}$ February, 2020 considered and decided to issue a Final Show Cause Notice was issued to the institution vide dated 27.02.2020. The institution has submitted its reply along with documents vide dated 17.03.2020.

AND WHEREAS, the matter was finally considered the SRC in its 395^{th} meeting held on $25^{th} - 26^{th}$ February, 2021 considered the matter and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply submitted by the institution on 17.03.2020 in response to the Final Show Cause Notice. The Committee found the following deficiency:-

- 1. The institution has submitted certified copy of Land Documents.
- 2. The institution has submitted notarized copy of Non-Encumbrance in regional language.
- 3. The institution has submitted photocopy of Building Plan in which approving authority seal in regional language, total built up area, and multipurpose Hall not sufficient as per NCTE Regulation 2014.
- 4. The institution has submitted attested copy Building Completion Certificate in which Survey No not mentioned and not approved by competent authority.
- The institution has submitted a letter of faculty list Signed by the Registrar, Tamilnadu Teachers Education University vide dated 21.10.2016 & 28.04.2016.
 - (i) The institution has not submitted faculty in 04 Perspective of Education and 01 Fine Arts.
 - (ii) The institution has not submitted latest copy of faculty list duly approved by affiliating body.

Hence, the Committee decided to withdraw the recognition granted to the institution namely, Arulmigu Kalasalingam College of Education, Anand Nagar, Krishnankoil, Srivilliputtur Taluk, Virudhunagar District, Tamilnadu-626190 for conducting B.Ed course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Arulmigu Kalasalingam College of Education, Anand Nagar, Krishnankoil, Srivilliputtur Taluk, Virudhunagar District, Tamilnadu-626190 run by Kalasalingam and Anandam Ammal Charities, Chennai, Tamilnadu-626190 for conducting B.Ed. programme of two years duration with an annual intake of 100 for two-basic units of 50 students each w.e.f. the next academic session i.e. 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
