**WITHDRAWAL ORDER**

**WHEREAS**, the institution was granted recognition namely **Karnataka Teacher College, Bijapur Road, Indi, Bijapur District, Karnataka-586209** run by **Karnataka Vidya Vardhaka Sanga, Indi, Bijapur District, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/295 dt. 28.01.2005 for conducting B.Ed. (Secondary) course of one year' duration with an annual intake of 100 students from the academic session 2004-2005.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 02.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

**AND WHEREAS**, provisional revised recognition order was issued to the institution on 18.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 for two basic units of 50 students from the academic session 2015-16 with a condition to maintain.**

**AND WHEREAS**, the SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> October & 01<sup>st</sup> November 2019 considered the matter and decided to issue a SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a Show Cause Notice was issued to the institution on 18.08.2019.

**AND WHEREAS**, the matter was placed before the SRC in its 388<sup>th</sup> Meeting held on 14<sup>th</sup> & 15<sup>th</sup> September 2020 considered and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision Final Show Cause Notice was issued to the institution on dt. 12.10.2020. Thereafter, the institution submitted its reply on dt. 04.11.2020.

**AND WHEREAS**, the matter was placed before the SRC in its 395<sup>th</sup> Meeting held on 25<sup>th</sup> & 26<sup>th</sup> February 2021 and considered the matter as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply submitted by the institution on **04.11.2020** in response to the Final Show Cause Notice. The Committee found the following deficiency: -

1. As per the staff list submitted by the institution: -
  - a. The institution submitted a copy of letter dt. 29.11.2019 issued by the R.C. University regarding approval of 14 faculty. The faculty strength is not sufficient for 2 units of B.Ed. course as required under Appendix 4 of NCTE Regulations, 2014.
  - b. 8 faculty members, out of 14 are not qualified as do not possess NET qualification as required under NCTE Regulations, 2014 (amended vide notification dt 09.06.2017) and date of joining is after the referred notification.
2. The institute submitted FDR of Rs 4,34,984/- but the same is matured on 29.11.2020. Another FDR of Rs 4 Lakh only. The institution is failed in maintaining FDRs of Rs 5+7 Lakhs as required under NCTE Regulations, 2014. And Form A issued by the concerned bank has not been submitted.
3. The institution has not submitted a blueprint of approved Building.
4. The Committee also noted that the institution has not shifted the building from the temporary accommodation to permanent accommodation.

**Hence,** the Committee decided to withdraw the recognition granted to the institution namely **Karnataka Teacher College, Bijapur Road, Indi-586209, Bijapur District, Karnataka** for conducting **B.Ed. course** with effect from the next academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

**NOW THEREFORE,** the Committee decided to withdraw the recognition granted to **Karnataka Teacher College, Bijapur Road, Indi, Bijapur District, Karnataka-586209** run by **Karnataka Vidya Vardaka Sangha Indi, Bijapur District, Karnataka** for conducting **B.Ed. course** of two years duration with an annual intake of 100 students (two basic units) with effect from the next academic session i.e., 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

*"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."*
