WITHDRAWAL ORDER

WHEREAS, the institution namely **Sri Nandhishwara Gramantara B.Ed. College, Nandigudi, Harihar Taluk, Davanagere District, Karnataka-577516** run by **Sri Nandishwara Vidya Samsthe, Nandigudi, Davanagere District, Karnataka** was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/9011 dt. 01.12.2004 for conducting B.Ed. (Secondary) course of one year' duration with an annual intake of 100 students from the academic session 2004-2005.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 20.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 27.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 for two basic units of 50 students from the academic session 2015-16 with a condition to maintain.**

AND WHEREAS, a Corrigendum was issued to the institution for granted 1 basic unit of B.Ed. course on dt. 01.07.2015.

AND WHEREAS, the SRC in its 369th meeting held on dt. 28.01.2019 considered the matter and decided to issue Show Cause Notice to the institutions which have not submitted compliance to the RPRO. Accordingly, a Show Cause Notice was issued to the institution on dt. 05.02.2019.

AND WHEREAS, the SRC in its 388th meeting held on 14th & 15th September 2020 wherein general decision was taken that the Final Show Cause Notice be issued to the institutions those have not submitted any reply to the earlier notices or RPRO compliance.

AND WHEREAS, a Final Show Cause Notice was issued to the institution on dt. 13.10.2020. Thereafter, the institution has submitted its reply on dt. 11.11.2020.

AND WHEREAS, the matter was placed before the SRC in its 395th Meeting held on 25th & 26th February 2021 and considered the matter as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

"The Committee considered the reply submitted by the institution on 11.11.2020 in response to the Final Show Cause Notice. The Committee found the following deficiency: -

1. The institution has submitted photocopy of Building Plan and Building Completion Certificate wherein the Building Plan is proposed at Survey No. 79 and the Building Completion Certificate issued on Survey NO. 52. There is a clear contradiction in both documents at Survey No.
2. The institution has submitted Building Plan which is not approved by the competent authority. Also, the total built up area is not adequate to run 1 unit of B.Ed. course as per NCTE Regulations, 2014. The size of the multipurpose hall is not mentioned.
3. The institution has not submitted site Plan duly approved by the competent authority.
4. The Building Completion Certificate submitted by the institution wherein the land is shown on "Lease". The Building Completion Certificate submitted by the institution wherein the total built up area is not adequate to run 1 unit of B.Ed. course as per NCTE Regulations, 2014. The size of the multipurpose hall is not mentioned.
5. The institution has not submitted latest staff list in prescribed format duly approved by the Registrar of concerned affiliating university.

Hence, the Committee decided to withdraw the recognition granted to **Sri Nandishwaras Gramantara B.Ed College, Nandigudi, Harihara Taluk – 577516, Davangere District, Karnataka** for conducting **B.Ed. course** with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, the Committee decided to withdraw the recognition granted to **Sri Nandhishwara Gramantara B.Ed. College, Nandigudi, Harihar Taluk, Davanagere District, Karnataka-577516** run by **Sri Nandishwara Vidya Samsthe, Nandigudi, Davanagere District, Karnataka** for conducting **B.Ed. course** of two years with effect from the next academic session i.e., 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of

employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
