CONTINUATION ORDER

WHEREAS, the institution was granted recognition namely, **Digvijaya Rural College of Education, Hadavanahalli Gate, Near Mysore Cement Factory, Turuvekere Taluk-572211, Tumkur District, Karnataka** run by **Sri Vishwabharathi Education Society, Gubbi, Tumkur District, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2004-2005/8905 dt.30.11.2004 for conducting B.Ed. (Secondary) course of one year' duration with an annual intake of 100 students from the academic session 2004-2005.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 06.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 students two basic units from the academic session 2015-16 with a condition to maintain.**

3. **AND WHEREAS**, as per the request of the institution the matter was placed before the SRC in its 346th meeting held on 24th – 25th October, 2017 the Committee considered the matter and decided to issue an order for the reduction of intake from 2 units to 1 unit. Accordingly, a order was issued to the institution on 02.11.2017.

4. **AND WHEREAS**, the case of the institution for final consideration of RPRO compliance issued vide order No. F.SRO/NCTE/APS01905/B.Ed./KA/2015-16/66149 dated 31.05.2015 was placed before the SRC in its 395th meeting held on 25th-26th February 2021 and the Committee decided as follows:-

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations, Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution **Digvijaya Rural College of Education, S. No. 110, Hadavanahalli Gate, Near Heidelberg Cement Factory, Dandinashivara Hobli, Turuvekere Taluk, Tumkur District, (Hadavanahalli Panchayath), Tumkur District, Karnataka 572211** for B.Ed. programme for 1 basic unit of 50 students.

In addition to the above, the Committee also decided that the request of the institution for additional intake in B.Ed. course is not acceptable."

5. **NOW THEREFORE**, the SRC decided to permit the institution i.e., **Digvijaya Rural College of Education, Sy. No. 110, Hadavanahalli Gate, Near Heidelberg Cement Factory, Dandinashivara Hobli, Turuvekere Taluk, Tumkur District, (Hadavanahalli Panchayath), Tumkur District, Karnataka 572211** run by **Sri Vishwabharathi Education Society, Gubbi, Tumkur District, Karnataka-572216** for continuation of recognition for **B.Ed. course of two**

years duration with an annual intake of 50 students (one basic unit) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
6. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
 7. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
 8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
 9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

10. The institution shall make available the list of students admitted on its official website.
11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
