WITHDRAWAL ORDER 124659 - 4666

WHEREAS, the institution was granted recognition namely Sarvodaya College of Education, Ambatti, Virajpet, Kodagu District, Karnatka-571218 run by Sarvodaya Educational Trust, Ambatti, Virajpet, Kodagu District, Karnatka-571218 vide SRC (NCTE) order no. F.KAR/B.Ed./58/SRO/NCTE/2000-2001/946 dt. 11.07.2000 for conducting B.Ed. (Secondary) course of one year' duration with an annual intake of 100 students from the academic session 2000-2001.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 23.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 for two basic units of 50 students from the academic session 2015-16 with a condition to maintain.

AND WHEREAS, a Corrigendum was issued to the institution vide order no. F.SRO/NCTE/AOSO0461/B.Ed./KA/2015/76976 dt. 27.10.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016.

AND WHEREAS, the SRC in its 369th meeting held on dt. 28.01.2019 considered the matter and decided to issue Show Cause Notice to the institutions which have not submitted compliance to the RPRO. Accordingly, a Show Cause Notice was issued to the institution on dt. 25.04.2019. Thereafter, the SRC in its 388th meeting held on 14th & 15th September 2020 wherein general decision was taken that the Final Show Cause Notice be issued to the institutions those have not submitted any reply to the earlier notices or RPRO compliance.

AND WHEREAS, as per the decision a Final Show Cause Notice was issued to the institution on dt. 16.10.2020. Thereafter, the institution has submitted its reply on dt. 25.11.2020.

AND WHEREAS, the matter was placed before the SRC in its 395^{th} Meeting held on 25^{th} & 26^{th} February 2021 and considered the matter as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply submitted by the institution on 18.11.2020 in response to the Final Show Cause Notice. The Committee found the following deficiency: -

- 1. The Building Plan submitted by the institute is neither approved nor legible.
- 2. The institute submitted a letter dated 12.22.2020 issued by the Registrar, Mangalore University but for only 4 faculty which is not sufficient for running B.Ed. Course of 2 units.
- 3. 4 Faculty is approved on 12.11.2020 but shown to be appointed in 2006.
- 4. The institute did not submit LAND USE CERTIFICATE issued by the Competent Authority.
- 5. Form 'A' regarding FDRs issued by the bank has not been submitted.
- 6. The documents of land submitted is different from the documents submitted at the time of Recognition.

Hence, the Committee decided to withdraw the recognition granted to the institution namely, Sarvodaya College of Education, Sy.No.: 25/12, Ambatti, Virajpet-571218, Kodagu District, Karnataka for conducting B.Ed course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

NOW THEREFORE, the Committee decided to withdraw the recognition granted to Sarvodaya College of Education, Sy.No.: 25/12, Ambatti, Virajpet-571218, Kodagu District, Karnataka run by Sarvodaya Educational Trust, Ambatti, Virajpet, Kodagu District, Karnatka-571218 for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) with effect from the next academic session i.e., 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order.
