**WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to **G.P. Teacher Education Training College, Makkanur Village, Tirupattur, Vellore, Tamilnadu – 635601** the SRC vide order No. F.TN/SEC/SRO/NCTE/2005-2006/2380 dated 12.08.2005 for conducting B.Ed. course of one year duration from the academic session 2005-2006 with an annual intake of 100 students. The initial recognition was granted to the institution **on the rented / temporary premise** i.e. land possessed through lease for a period of 5 years.

**AND WHEREAS**, consequent upon the decision taken by the SRC in its 202<sup>nd</sup> meeting held on 14<sup>th</sup> & 15<sup>th</sup> March 2011, the recognition of the institution for **both courses i.e. B.Ed. and D.T.Ed. was withdrawn** vide order dt. 18.04.2011.

**AND WHEREAS**, consequent upon the interim stay order (W.P.Nos. 11067 & 11068 of 2011) dt. 28.04.2011 passed by the Hon'ble H.C. at Madras, the SRC in its 296<sup>th</sup> meeting decided to issue RPRO and accordingly the RPRO was issued on 29.01.2016 for conducting B.Ed. programme of two year duration with an annual intake of 100 students each for two basic units from the academic session 2015-16.

**AND WHEREAS**, the institution applied for shifting of premise vide letter dated 15.06.2016 and the matter was considered by the SRC in its 316<sup>th</sup> meeting wherein the SRC decided to constitute VT to collect all relevant documents, and check. Adequacy of built up area for B.Ed. (2 units).

**AND WHEREAS**, the inspection of the institution for shifting of premise was conducted on 14.08.2016 and the report was considered by the SRC in its 323<sup>rd</sup> meeting and decided to issue SCN. Accordingly, the SCN was issued on 30.11.2016 and reply dt. 16.12.2016 was considered by the SRC in its 351<sup>st</sup> meeting and decided to SCN to the institution. Accordingly, the SCN was issued on 15.01.2018 and reply of the institution vide letter dt. 01.02.2018 has been received.

**AND WHEREAS**, the SRC in its 388<sup>th</sup> meeting held on 14-15 September 2020 considered the matter and the Committee decided to issue Final Show Cause Notice asking therein to submit requisite documents regarding infrastructural & instructional facility created by the institution. Accordingly, a Final Show Cause Notice was issued to the institution on **21.09.2020**.

**AND WHEREAS**, the institution vide letter dated **22.01.2021** has submitted its reply in response to the Final Show Cause Notice and the matter was finally considered the SRC in its 395<sup>th</sup> meeting held on 25<sup>th</sup> – 26<sup>th</sup> February, 2021 considered the matter and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee considered the reply submitted by the institution on 22.01.2021 in response to the Final Show Cause Notice. The Committee found the following deficiency:-

1. The institution has not submitted a LAND USE CERTIFICATE, NON - ENCUMBRANCE CERTIFICATE, Building Plan & BUILDING COMPLETION CERTIFICATE.
2. The institution has submitted a photocopy of Land Documents, Site Plan & Faculty list instead of notarized copy of these documents.
3. The institution has not submitted Form A issued by the respective Bank Manager and only photocopy of FDRs submitted.
4. As per SRC decision, VT was conducted on 27.08.2016. As per the records made available the shifting of premises to its own permanent building has not been permitted.

Hence, the Committee decided to withdraw the recognition granted to the institution namely, G.P. Teacher Education Training College, Makkanur Village, Tirupattur, Vellore, Tamilnadu – 635601 for conducting B.Ed course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.”

**NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **G.P. Teacher Education Training College, Makkanur Village, Tirupattur, Vellore, Tamilnadu – 635601** run by **Eswary Educational Trust, 23, Kovillore Road, Tirupattur-635601, Vellore, Tamilnadu** for conducting B.Ed. programme of two years duration with an annual intake of two basic units of 100 students w.e.f the next academic session i.e. 2021-2022 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

*“If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government.”*

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through “online mode” available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org), with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
