WITHDRAWAL ORDER

WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely, **Venkateswara College of Education, Ambajipeta (Mandalam), East Godavari District, Andhra Pradesh-533214** run by **Sri Vidya Educational Society, East Godavari District, Andhra Pradesh** vide order no. F.SRO/NCTE/B.Ed./2008/6013 dt. 10.10.2008 for conducting B.Ed. course with an annual intake of 100 students.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 15.07.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.07.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **50 students** for one **basic unit** from the academic session 2015-16.

3. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice issued on 28.02.2019. The institution has not submitted reply to the Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 405th meeting held on 27th – 28th January 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 04.03.2021. The institution has submitted reply on 31.05.2021.

5. **AND WHEREAS**, the SRC in its 408th Meeting held on 02nd March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 31.05.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. *The institution submitted a Performa of a faculty signed by the Registrar, A.N. University but the date of approval is not mentioned over it and the signature and Stamp is not visible. Six faculty namely, Sri MaddalaApparao, Sri ChitrapuSrimanikyakumar, Sri Usha Sri, Sri A. Pradeep Kumar, Sri ParammataYesu babu, Sri JVV Satyanarayana appointed after 09.06.2017 and not qualified with NET, hence are not eligible for appointment as per NCTE Regulations, 2014 (amended vide notification dt.09.06.2017). The institution also failed to submit supporting documents in terms of educational qualification of the faculty and experience certificate of the Principal.*



2. *The institution only submitted FDRs for Endowment and Reserve Funds amounting to Rs. 8 lakhs which is not sufficient as per NCTE Regulations, 2014.*
3. *The institution did not submit Form 'A' issued by the bank regarding maintenance of FDRs for Endowment and Reserve Funds.*
4. *As per building plan the size of multi-purpose hall is only 169.55 sqm. (1825.02 sq.ft.) which is less than the requirement of NCTE Regulations, 2014.*
5. *Details of functional website of the institution has not been submitted.*
6. *Affidavit as directed to submit vide Final Show Cause Notice dt.04.03.2021 has not been submitted.*
7. *The institute failed in submission of the bank statement of all individual faculty and institution's bank statement duly certified by the concerned bank showing disbursement of salary through bank Account to faculty as required under clause 10 (3) of NCTE Regulation, 2014.*

*Hence, the Committee decided to **withdraw the recognition granted to Venkateswara College of Education, Ambajipeta (Mandalam), east Godavari District-533214, Andhra Pradesh** for conducting **B.Ed. programme** with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."*

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Venkateswara College of Education, Ambajipeta (Mandalam), East Godavari District, Andhra Pradesh-533214** run by **Sri Vidya Educational Society, Ambajipeta (Mandalam), East Godavari District, Andhra Pradesh-533214** for conducting **B.Ed. programme** of two years duration with an annual intake of **50 students (1 basic unit)** with effect from the academic session i.e., 2022-2023 onwards.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
