WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely, Pasumpon Muthuramalinga Thevar College, Plot No. 3, Vadugapatti Village, Usilampatti, Madurai, Tamilandu-625532 vide order no. F.SRO/NCTE/SRCAPP14728 /B.P.Ed./TN/2017-2018/92765 dt. 07.04.2017 for conducting B.P.Ed. programme of two years duration with an annual intake of 100 (two sections of 50 students each) 1 unit from the academic sessions 2017-2018.

- AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 24.09.2020. The institution has submitted reply on 19.11.2020.
- AND WHEREAS, the SRC in its 404th Meeting held on 16th & 17th November, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 30.11.2021. The institution has submitted reply on 04.01.2022.
- AND WHEREAS, the SRC in its 408th Meeting held on 02nd March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 04.01.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted faculty approval letter dt. 28.02.2017. It had also submitted a copy of letter dated 01.03.2021 written to the Registrar, TNPESU seeking approval of 5 faculty but approval has not been submitted. The institute had failed in submission of approval of consolidated faculty list latest approved by the affiliating body. The institute also did not submit the Performa of faculty approved by the University. The institution also failed to submit supporting documents in terms of educational qualification of the faculty and experience certificate of the Principal.
- 2. The building plan is not approved by the competent authority.
- 3. As per building plan indoor sports facility, Gymnasium, multi-purpose plan field, 400 sgm. track is not available as require in Appendix 5 of NCTE Regulations, 2014.

- 4. As per Building plan the building is neither disabled friendly nor the fire hazard been provided as required under Appendix 5 of NCTE Regulations, 2014.
- 5. As per building plan separate hostels for boys and girls for outstation students been provided as required under Appendix 5 of NCTE Regulations, 2014
- 6. The institute failed in submission of the bank statement of all individual faculty and institution's bank statement—duly certified by the concerned bank showing disbursement of salary through bank Account to faculty as required under clause 10 (3) of NCTE Regulation, 2014.

Hence, the Committee decided to withdraw the recognition granted to Pasumpon Muthuramalinga Thevar College, Plot no. 3, Vadugapatti Village, Usilampatti, Madurai, Tamilnadu-625532 for conducting B.P.Ed. programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Pasumpon Muthuramalinga Thevar College, Plot no. 3, Vadugapatti Village, Usilampatti, Madurai, Tamilnadu-625532 run by Kallar Kalavi Kalagam, Plot No. Usilampatti Post and Taluk, Madurai District, Tamilandu-625532 for conducting B.P.Ed. programme of two years duration with an annual intake of 100 (two sections of 50 students each) 1 unit with effect from the academic session i.e., 2022-2023 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
