WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Sri Kanakadas D.Ed. College, C/O Beereshwar High School, No. 289 & 290, Bilagi, Bagalkot, Karnataka-587116 run by Shri Kalidas Education Society, Torvi Road, Bijapur, Karnataka vide order no. F.APSO9549/D.Ed./SRO/NCTE/2011-12/29081 dt. 13.06.2011 for conducting D.Ed. course of two years duration with an annual intake of 50 students from the academic session 2011-12.

2. AND WHEREAS, the Southern Regional Committee (SRC) in its 413^{th} Meeting held on $22^{\text{nd}} \& 23^{\text{rd}}$ August, 2022 discussed the matter about the institutions who failed to submit the PAR as advised by the PAR as advised by the NCTE and directed to the Regional Director, SRC to serve a Show Cause Notice to failure of submitted the PAR to all such institutions seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per decision of the SRC, a Show Cause Notice was issued to the institution on 02.12.2022.

3. AND WHEREAS, the institution has submitted a written representation dt. 13.12.2022 as under: -

"Received your letter no. 137719 SRC/NCTE-REG 1015/894/2022 regulation Section/SRC dated 2nd December 2022. We know the content. For this already we have submitted all the documents at the time of Shri Kanakadas D.Ed. College, Bilagi Dist. Bagalkot Sanction. Then afterwards we could not run the college due to the shortage of admission in the year 2015-16. So, we close the college and written to the Govt. DIET institution llkal on 25.06.2020 for closing of the college. Then district DIET officer visited dated 29.10.2022 and conformed the college closing. This letter is attached for kind information.

I hope you will consider our letter you can get information from state NCTE office Bangalore."

4. **AND WHEREAS**, the SRC in its 419th Meeting held on 13th January, 2023 has considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution vide letter dated 13.12.2022 by withdrawing the recognition granted to Sri. Kanakadas D.Ed. College, C/O Beereshwar High School, No. 289 & 290, Bilagi, Bagalkot, Karnataka-587116 for conducting D.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Sri. Kanakadas D.Ed. College, C/O Beereshwar High School, No. 289 & 290, Bilagi, Bagalkot, Karnataka-587116 run by Shri Kalidas Education Society, Torvi Road, Vijayapur, Karnataka - 586108 for conducting D.Ed. course of two years duration with an annual intake of 50 students from the academic session i.e., 2022-2023.

6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <u>www.ncte-india.org</u> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
