WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Maheswari College of Education, Kalavarai Village & Post, Bobbili Taluk & City, **District** Andhra Pradesh Vizianagaram 535558, order F.SRO/NCTE/SRCAPP14522/M.Ed/AP/2016-2017/84941 dated 02.05.2016 for conducting M.Ed programme of two-years duration with an annual intake of 50 students (1 unit) from the academic sessions 2016.2017.

- AND WHEREAS, the SRC in its 384th meeting held on 12th 13th February, 2020 has considered the matter and decided to continuation order. Accordingly, as per the decision of SRC an continuation order No. F.No.SRC/NCTE/SRCAPP14522/M.Ed/AP/2020/114900-114907 dated 21.02.2020 was issued to the institution.
- AND WHEREAS, the institution has submitted request dated 14.12.2022 for closure of M.Ed. Programme. The SRC in its 419th Meeting held on 13th January, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution vide letter dated 14.12.2022 by withdrawing the recognition granted to Maheswari College of Education, Kalavarai Village, Bobbili Taluk & City, Vizianagaram District-535558, Andhra Pradesh for conducting M.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC.

- NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993. the Southern Regional Committee hereby agreed to close down the institution by withdrawing recognition granted to Maheswari College of Education, Kalavarai Village & Post, Bobbili Taluk & City, Vizianagaram District - 535558, Andhra Pradesh for conducting M.Ed. programme of two years duration with an annual intake of 50 students (1 unit) with effect from the academic session i.e., 2022-2023 onwards.
- 5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
