CONTINUATION ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Sri Veerashwara VV Sangha College of Education, At Post Nalatwad, Muddebihal Taluk, Bijapur District – 586124, Karnataka** vide order no. F.SRO/NCTE/B.Ed./2004-2005/8686 dt. 25.11.2004 for conducting Secondary (B.Ed.) course of one year duration from the academic session 2004-2005 with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 22.01.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 16.05.2015 for conducting **B.Ed. course** of two years duration with an annual intake of **50 students for one basic unit of 50 students** from the academic session **2015-16**.

3. **AND WHEREAS**, the SRC in its 369th meeting held on 28.01.2019 has considered the matter and decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 25.04.2019. The institution did not submitted reply to the Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 431st meeting held on 10th January, 2024 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 24.01.2024. The institution has submitted reply on 23.02.2024.

5. **AND WHEREAS**, the SRC in its 434th meeting held on 22nd March, 2024 considered the matter and decided to issue last reminder letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 05.04.2024. The institution has submitted reply on 09.04.2024.

6. **AND WHEREAS**, the SRC in its 436th Meeting held on 02nd – 03rd May, 2024 has considered the matter and decided as follows: -

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

*The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Sri Veeraswhara VV Sangha College of Education, Survey No. 9A & 9B, Plot No. 14A, Ward No. 01, Post Nalatwad, Muddebihal Taluk, Bijapur District – 586124, Karnataka** for **B.Ed. programme for 1 basic unit of 50 students.**"*

7. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Sri Veeraswhara VV Sangha College of Education, Survey No. 9A & 9B, Plot No. 14A, Ward No. 01, Post**

Nalatwad, Muddebihal Taluk, Bijapur District – 586124, Karnataka for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.



11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
12. The institution shall make available the list of students admitted on its official website.
13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
