AND WHEREAS, the SRC its 345th Meeting held during 21st & 22nd September, 2017 considered the reply of the institution for the decision of 329th Meeting and decided that Show Cause Notice be issued to the institution. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 06.10.2017. The institution has submitted reply on 23.10.2017.
- 4. AND WHEREAS, the SRC in its 431st meeting held on 10th January, 2024 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 24.01.2024. The institution has submitted reply on 31.01.2024 & 26.02.2024.
- 5. AND WHEREAS, the SRC in its 436th Meeting held on 2nd & 03rd May, 2024 considered the matter and decided to issue last reminder letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 15.05.2024. The institution has submitted reply on 22.05.2024.
- 6. AND WHEREAS, the SRC in its 438th Meeting held on 03rd June, 2024 has considered the matter and decided as follows: -

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Smt. Indira B.Ed. College, Survey No. 241 & 241/1, Revenue Khata No. 64/241:1, Budikote, Bangarpete Tq, Kolar District, Karnataka-563114 for B.Ed. programme for 2 basic units of 50 students each."

- 7. NOW THEREFORE, this order is issued permitting the institution i.e., Smt. Indira B.Ed. College, Survey No. 241 & 241/1, Revenue Khata No. 64/241:1, Budikote, Bangarpete Tq, Kolar District, Karnataka-563114 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - The institution shall comply with the various other norms and standards prescribed in II. the NCTE Regulations, 2014 as amended from time to time.
 - The institution shall make admissions only after it obtains affiliation from the III. examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - The institution shall ensure that the required number of academic staff duly approved IV. by affiliating body for conducting the course should always remain in position.
- Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee as Self Appraisal Report at 9. the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and nonteaching staff with photographs, for information of all concerned. - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 12. The institution shall make available the list of students admitted on its official website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website.
