PREAMBLE:

Dr. M.G.R. Educational & Research Institute, Periyar E.V.R. High Road (NH 4 Highway), Maduravoyal, Chennai – 600 095, Tamilnadu submitted an application seeking grant of recognition for B.Ed course on 21.07.2003 without NOC / Endorsement from the State Government of Tamilnadu.

In obedience to the directions passed by the Hon'ble High Court of Madras in W.P. No. 23466 of 2003 dated 27.07.2004 filed by the institution SRC-NCTE caused inspection of the institution on 21.03.2005. The visiting team report of the institution was placed before 93rd SRC meeting held on 15th June, 2005. SRC decided to write to the State Government of Tamilnadu for opinion. The institution vide their compliance dated 10.10.2005 has submitted the Endorsement dated 11.08.2005 issued by the State Government of Tamilnadu. The same was placed before the 102nd SRC meeting held on 19th October, 2005. SRC decided to accord recognition to the institution to offer B.Ed. course from the academic session 2005-06 with an intake of 100 students. Hence the order:

ORDER

In terms of Section 15 (1) of the NCTE Act, 1993 **Dr. M.G.R. Educational & Research Institute, Periyar E.V.R. High Road (NH 4 Highway), Maduravoyal, Chennai – 600 095, Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for **Secondary (B.Ed) Teacher Training Course of one year duration** from the academic session **2005-06**.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- a. The institution has submitted a court direction for considering their proposal.
- b. The institution has acquired the land for setting up the teacher education institution.

- c. The institution will ensure that the permanent building is constructed within a period of 3 years on the acquired land.
- d. The institution has created an Endowment fund of Rs. 5.00 lakhs and a Reserve fund of Rs. 3.00 lakhs.
- e. The institution has selected the **Principal** and seven teachers for the said course.

3. Now therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **Dr. M.G.R. Educational & Research Institute, Periyar E.V.R. High Road (NH 4 Highway), Maduravoyal, Chennai - 600 095, Tamilnadu** to offer Secondary (B.Ed) course of one year duration from the academic session **2005-06** with an annual intake of **100** students, subject to fulfillment of the following.

- a) The institution will ensure that **Eight** exclusive faculty members (**Principal and Seven teachers**) duly approved by the DTERT are in position for an intake of **100** students and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case before commencement of admissions for the course.
- b) The institution shall shift to its own premises within three years from the date of recognition (in case the course is started in temporary premises).
- c) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.
- d) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.

5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating authority to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Southern Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.
