CONTINUATION ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Indira Gandhi Training College, Opp. Telephone Exchange, Kothamangalam, Ernakulam District, Kerala - 686691** vide order no. F.KL/SEC/N/190/SRO/NCTE/2004-2005/770 dt. 23.02.2005 for conducting secondary course of one year duration from the academic session 2004-2005 with an annual intake of 100.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 20.02.2015 for its willingness of one unit in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 13.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 50 Students (one basic unit) from the academic session 2015-16.**

3. **AND WHEREAS**, the matter regarding compliance by the institution of the conditions of the revised recognition order, was placed before the SRC in its 369th Meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on dt. 13.03.2019. Thereafter, the institution has submitted reply of Show Cause Notice on 19.01.2021.

4. **AND WHEREAS**, the SRC in its 395th Meeting held on 25th & 26th February, 2021 has considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 10.03.2021. The institution has submitted reply of Final Show Cause Notice on 26.03.2021 & 30.08.2021.

5. **AND WHEREAS**, the SRC in its 405th meeting held on 13th – 14th December 2021 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal order No. F.SRO/NCTE/APS00576/B.Ed./KL/2021/129655 was issued to the institution on 29.12.2021.

6. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No.89-16/E-235495/2022 Appeal/3rdMeeting, 2022 Appeal No. APPLSRC202214245 dated 18.04.2022 and the *Appeal Committee of the council concluded that SRC was justified in withdrawing recognition and therefore, the appeal deserved to be rejected and order of the SRC is confirmed.*

7. **AND WHEREAS**, the SRC in its 411st meeting held on 23rd -24th May 2022 has considered the matter and decided as under:-

“The Committee noted the order of the Appellate Authority confirming the withdrawal order issued by the SRC, NCTE. Further the office of the Regional Director, SRC is advised to return the FDRs to the institution by following the prescribed rules and close the file and inform the respective affiliating body/University and the State Govt.”

8. **AND WHEREAS**, the institution has filed Writ Petition before Hon'ble High Court of Kerala at Ernakulam bearing W.P(C) No. 30055/2022 titled as Indira Gandhi Memorial Trust Versus National Council for Teacher Education & others Whereby the Hon'ble High Court has directed to submit the documents. As per direction of Hon'ble High Court of Kerala the institution has submitted required documents on 09.11.2022.

9. **AND WHEREAS**, the SRC in its 416th Meeting held on 22nd November, 2022 has considered the matter and decided to issue Final Show Cause Notice to the institution. But, as per the uploaded decision on website the institution has submitted its reply on 01.12.2022 through email.


10. **AND WHEREAS**, the SRC in its 417th Meeting held on 01st & 02nd December, 2022 considered the matter and decided as follows: -

“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -


The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Indira Gandhi Training College, Survey No. 83/3, 83/4A, 84/5, 83/5-C, 83/4-B,84/6, 84/7, Ward X, Eramallor, Village Eramalloor, Nellikuzhi Panchayat, Kothamangalam, Eranakulam District, Kerala- 686691 for B.Ed. programme, 1 basic unit of 50 students.”

11. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Indira Gandhi Training College, Survey No. 83/3, 83/4A, 84/5, 83/5-C, 83/4-B,84/6, 84/7, Ward X, Eramallor, Village Eramalloor, Nellikuzhi Panchayat, Kothamangalam, Eranakulam District, Kerala- 686691** run by **Indira Gandhi Memorial Trust, Survey No. 83/3, 83/4A, 84/5, 83/5-C, 83/4-B,84/6, 84/7, Ward X, Eramallor, Village Eramalloor, Nellikuzhi Panchayat, Kothamangalam, Eranakulam District, Kerala- 686691** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.




- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
12. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
13. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
- a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
16. The institution shall make available the list of students admitted on its official website.



17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
