WHEREAS, the recognition was granted to the institution namely, Sree Rama College of Education, Sreenivasapuram, Tiruchanoor Road, Tiruchanoor Post, Tirupati, Andhra Pradesh-517503 run by Sree Rama Educational Society, Tirupati, Andhra Pradesh vide order no. F.SRO/NCTE/M.Ed./2007-2008/15463 dt. 03.12.2007 for conducting M.Ed. course of one year duration with an annual intake of 25 (twenty five) students.

- 2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to Parasakthi College of Education, S. Kottaipatti, Madurai District-625527, TamilNadu vide order No. F.SRO/NCTE/2010-2011/20539 dated 20.08.2010 from the academic session 2010-2011.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students for one basic unit from the academic session 2015-16.
- 4. AND WHEREAS, the SRC in its 369th Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, a Show Cause Notice was issued to the institution on 05.02.2019.
- 5. **AND WHEREAS,** the SRC in its 388th meeting held on 14th 15th September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 22.02.2021. The institution has not submit reply to the Final Show Cause Notice.
- **6. AND WHEREAS,** the SRC in its 408th Meeting held on 02nd March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee noted that the institution has not replied to the Final Show Cause Notice dated 22.02.2021.

Hence, the Committee decided to withdraw the recognition granted to Sree Rama College of Education, Sreenivasapuram, Tiruchanoor Road, Tirupathi-517503, Chittoor District, Andhra Pradesh for conducting M.Ed. programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sree Rama College of Education, Sreenivasapuram, Tiruchanoor Road, Tirupathi-517503, Chittoor District, Andhra Pradesh run by Sree Rama Educational Society, Tirupati, Andhra Pradesh for conducting M.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2022-2023 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
