**WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely St. John's College of Education, No. 18, North High Ground Road, Palayamkottai, Tirunelveli District, Tamilnadu-627002 run by Church of South India-Tirunelveli Diocese Trust Association, Tirunelveli District, Tamilnadu - 627002 on dt. 08.02.2008 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dt. 19.01.2015 for its willingness for adherence of provisions of new Regulations.

**AND WHEREAS**, the revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

**AND WHEREAS**, the SRC in its 376<sup>th</sup> meeting considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued on 20.06.2019. Thereafter, the reply of Show Cause Notice was placed before the SRC in its 382<sup>nd</sup> meeting. The Committee Considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued on 03.12.2019.

**AND WHEREAS**, the institution has submitted its reply on 02.01.2020 requesting in respect of Final Show Cause Notice.

**AND WHEREAS**, the matter was finally considered by the SRC in its 384<sup>th</sup> meeting held on 12<sup>th</sup> - 13<sup>th</sup> February 2020 decided as under:-

*The Management of the Institution had not submitted required documents in response to letter issued to the Institution on 20.06.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 03.12.2019. The institution vide letter dated 02.01.2020 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under :-*

1. The institution submitted land showing ownership whereas the NEC shows the land on lease.

2. *The LUC is not the proper format of State Govt.*
  3. *The institution submitted a copy of Building Plan which is not approved.*
  4. *The BCC is not approved.*
  5. *The institution has only submitted approval of affiliating University only in respect of 14 against the requirement of 15 under NCTE regulations. The faculties namely Roselin Diana, Selakumari J, R. Bala Subramanian and Edwin Devadoss. T are not qualified as per NCTE Regulations. Further letters regarding approval of faculties issued by the university have not been submitted.*
  6. *The institution did not submit documents regarding Trust/Society.*
  7. *The institution did not submit details of uploading requisite information on website.*

*Hence, the Committee decided to withdraw the recognition granted to St. John's College of Education, No. 18, North High Ground Road, Palayamkottai, Tirunelveli District, Tamilnadu-627002 for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.*

**NOW THEREFORE**, in exercise of the powers vested u/s 17 of 1993 of NCTE Regulations the institution namely **St. John's College of Education, No. 18, North High Ground Road, Palayamkottai, Tirunelveli District, Tamilnadu-627002** run by **Church of South India-Tirunelveli Diocese Trust Association, Tirunelveli District, Tamilnadu - 627002**, is hereby withdrawn for conducting **B.Ed** programme of two years duration with an annual intake of 100 students on the grounds mentioned above. The withdrawal of recognition is effective from the academic session commences next to issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org), with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
