**WITHDRAWAL ORDER**

**WHEREAS**, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, **Mahatma Gandhi University College of Teacher Education, Erattupetta, Kottayam District, Pin – 686121, Kerala** vide order no. F.SRO/NCTE/B.Ed/2007-2008/13905 dated 01.11.2007 for conducting Secondary (B.Ed.) course of one year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 17.06.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 08.07.2015 for conducting **B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.**

3. **AND WHEREAS**, the SRC in its 405<sup>th</sup> meeting held on 13<sup>th</sup> – 14<sup>th</sup> December, 2021 considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 27.12.2021. The institution has submitted reply vide letter dated 14.03.2022 & 21.03.2022.

4. **AND WHEREAS**, the SRC in its 409<sup>th</sup> meeting held on 29<sup>th</sup> – 30<sup>th</sup> March, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 18.04.2022. The institution has submitted reply vide letter dated 06.05.2022.

5. **AND WHEREAS**, the SRC in its 425<sup>th</sup> Meeting held on 18<sup>th</sup> May, 2023 considered the matter and decided as under: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -*

*The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 06.05.2022. The Committee perused the reply submitted by the institution and found the following deficiencies.*

- 1. The institution did not submit faculty list as per prescribed format of NCTE Regulation, 2014. The faculty list submitted by institution is not approved by affiliating body. The institution has submitted faculty list of 1.Principal + Ten Faculty for Assistant Professor in which three faculties were part timer.*
- 2. The institution is required to submit latest consolidated Staff list duly approved by the Registrar of the University as per the prescribed Format along with a copy of appointment letters. (In case the institution is running more than one*

teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)

3. The Committee noted that the institution has changed the management of the Mahatma Gandhi University College of Teacher Education to Centre for Professional and Advanced Studies and in view of the letter dated 08.12.2016 and 23.12.2016 issued by NCTE, Hqr., the change of management/Society/trust is no permissible

Hence the recognition granted **Mahatma Gandhi University College of Teacher Education, Erattupetta, Kottayam District, Kerala-686121** for **B.Ed. programme** is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing **B.Ed. programme** is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws the recognition granted to **Mahatma Gandhi University College of Teacher Education, Erattupetta, Kottayam District, Kerala-686121** for conducting **B.Ed. programme** of two years duration with an annual intake of **(1 basic unit) 50 students**. No fresh admissions are permitted now onwards. However, if any student is pursuing **B.Ed. programme** is allowed to continue till they complete the course.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."**


**"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी**



**राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")**

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
