WITHDRAWAL ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, **Kannur University Teacher Education Centre, Dwarakanagar, Kasaragod District, Pin - 676612, Kerala** vide order no. F.KL/SEC/N/362/SRO/NCTE/2005-2006/2326 dated 09.08.2005 for conducting Secondary (B.Ed.) course of one year duration with an annual intake of 100 students from the academic session 2005-2006.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 10.04.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 27.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.**

3. **AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 and 387th meeting held on 24th - 25th August, 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. On perusal of the records, it is found that the institution has not submitted the following documents/information. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 16.09.2020. The institution has submitted reply vide letter dated 29.12.2020.

4. **AND WHEREAS**, the SRC in its 410th meeting held on 25th - 26th April, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 12.05.2022. The institution has submitted reply vide letter dated 06.06.2022.

5. **AND WHEREAS**, the SRC in its 413th meeting held on 22nd - 23rd August, 2023 has considered the matter and decided to issue a last reminder letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 05.09.2022. The institution has not submitted reply to the last reminder letter.

6. **AND WHEREAS**, the SRC in its 425th Meeting held on 18th May, 2023 considered the matter and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

(i) *The institution failed to submit reply to the Last Reminder Letter dated 05.09.2022.*

Hence the recognition granted to Kannur University Teacher Education Centre, Dwarakanagar, Kasaragod District, Pin-676612, Kerala for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted

now onwards. However, if any student is pursuing **B.Ed. programme** is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn."

7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws the recognition granted to **Kannur University Teacher Education Centre, Dwarakanagar, Kasaragod District, Pin-676612, Kerala** for conducting **B.Ed. programme** of two years duration with an annual intake of 100 students (**2 basic units**) **50 students each**. No fresh admissions are permitted now onwards. However, if any student is pursuing **B.Ed. programme** is allowed to continue till they complete the course.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -


"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(8. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
