WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Thiruvalluvar Teacher Training Institute, Ammananguppam, Gudiyattam Railway Station Road, Katpadi Taluk, Vellore District, Tamilnadu-635803 for conducting Elementary course & D.EI.Ed. -AI course as per following details: -

- Vide order no. F.TN/947/SRO/NCTE/2004-2005/6813 dt. 09.09.2004 for conducting Elementary course of two-years duration from the academic session 2004-2005 with an annual intake of 50 students.
- (ii) For conducting **D.EI.Ed.-AI programme** of two -years duration with an annual intake of 50 students.
- AND WHEREAS, the Southern Regional Committee (SRC) in its 413th Meeting held on 22nd & 23rd August, 2022 discussed the matter about the institutions who failed to submit the PAR as advised by the NCTE and directed to the Regional Director, SRC to serve a Show Cause Notice to failure of submitting the PAR to all such institutions seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per decision of the SRC, a Show Cause Notice was issued to the institution on 27.01.2023 to Elementary course & D.EI.Ed. programme.
- AND WHEREAS, the institution has submitted a written representation dt. 07.02.2023 as 3. under: -

"With reference to the above, we submit that we have already surrendered the original as well as additional intake of students (50+50) granted by NCTE under APSO4747 and APSO1013 to Thiruvalluvar Teacher Training Institute, Gudiyattam, Vellore District 635803, Tamilnadu.

Under these circumstances we submit that the PAR in respect of Thiruvalluvar Teacher Training could not be submitted to the NCTE.

This is submitted for information."

AND WHEREAS, the SRC in its 422nd Meeting held on 02nd & 03rd March, 2023 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the Institution vide letter dated 10.02.2023 by withdrawing the recognition granted to Thiruvalluvar Teacher Training Office: G-7 Sector-10,

Institute, Ammananguppam, Gudiyattam Railway Station Road, Katpadi Taluk, Vellore District-635803, Tamilnadu for conducting D.El.Ed. & D.El.Ed-Al Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by institution vide letter dated 10.02.2023 withdrawing recognition granted to Thiruvalluvar Teacher Training Institute, Ammananguppam, Gudiyattam Railway Station Road, Katpadi Taluk, Vellore District-635803, Tamilnadu run by Kunja Kousalya Ammal Govindarajan Educational & Charitable Trust, Railway Station Road, Ammanankuppam, Gudiyattam, Tamilnadu-635803 for conducting annual intake of 50 students for Elementary course and conducting D.EI.Ed.-AI programme of two years duration for additional intake of 50 students with effect from end of the academic session i.e., 2022-2023.
- 6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(6. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्निलिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
