WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Viswavani College of Education, Atmakur Road, Opp: Nandyal Public School, Nandyal, Andhra Pradesh-518501 vide order no. F.SRO/NCTE/2001-2002/46/7980 dt. 24.09.2001 for conducting Secondary course with an intake of 160 students from the academic session 2001-2002.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 29.01.2015 for its willingness and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 14.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 150 students (three basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 381st Meeting held on 31st October & 01st November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 10.12.2019. The institution did not submit any reply to Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 415th meeting held on 03td 04th November, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 21.11.2022. The institution did not submit any reply to Final Show Cause Notice
- 5. AND WHEREAS, the SRC in its 421st Meeting held on 10th February, 2023 has considered the matter and decided as under:

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

(i) The institution failed to submit reply to the Final Show Cause Notice dated 21.11.2022.

Hence the recognition granted Viswavani College of Education, 22/24, Fort (Near Ramalayam), Nandyal — 518501, Kurnool District, Andhra Pradesh for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till, they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.

However, the FDRs towards Reserve Fund and Endowment Fund/No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."
