**WITHDRAWAL ORDER**

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Nandini D.Ed. College, Rampur Village, Raichur District, Karnataka-5874101 run by Dr. Narasimulu Nandini Memorial Education Trust, Raichur, Karnataka - 584101 vid order no. F.SRO/NCTE/D.Ed./2005-2006/4786 dt. 21.12.2005 for conducting Elementary (D.Ed.) course of two and half year's duration from the academic session 2005-06 with an annual intake of 50 students.

2. AND WHEREAS, the SRC in its 412<sup>th</sup> Meeting held on 05<sup>th</sup> & 06<sup>th</sup> July, 2022 took note about non-functioning of the website of the institutions which is mandatory requirement as per NCTE Regulations, 2014. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 05.08.2022. The institution has submitted reply to Show Cause Notice on 02.09.2022.

3. AND WHEREAS, the SRC in its 417<sup>th</sup> Meeting held on 01<sup>st</sup> & 02<sup>nd</sup> December, 2022 has considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 12.12.2022. The institution did not submit any reply to Final Show Cause Notice.

4. AND WHEREAS, the SRC in its 421<sup>st</sup> Meeting held on 10<sup>th</sup> February, 2023 has considered the matter and decided as under: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -*

(i) *The institution failed to submit reply to the Final Show Cause Notice dated 12.12.2022.*

*Hence the recognition granted Nandini D.Ed. College, Rampur Village, Raichur District, Karnataka-584101 for D.Ed. programme is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing D.Ed. programme is allowed to continue till, they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.*

*However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."*

5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws the recognition granted to Nandini D.Ed. College, Rampur Village, Raichur District, Karnataka-584101 run by Dr. Narasimulu Nandini Memorial Education Trust, Raichur, Karnataka-584101 for conducting D.Ed. programme of two and half year's duration with an annual intake of 50 students. No fresh admissions are permitted now onwards. However, if any student is pursuing D.Ed. programme is allowed to continue till, they complete the course.

6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

*"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."*

(6. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहाँ कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विद्यविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
