WITHDRAWAL ORDER**

WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely N.S.S. Training College, Pandalam Post, Pathanamthitta District – 689501, Kerala vide order No. F.SRO/NCTE/M.Ed./2007-2008/17938 dated 13.02.2008 for Conducting (M.Ed.) Course of one year duration with an annual intake of 25 students.

2. AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 was permitted to N.S.S. Training College, Pandalam Post, Pathanamthitta District – 689501, Kerala vide order No. F.SRO/NCTE/2010-2011/20789 dated 27.08.2010 from the session 2010-2011.

3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted an affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 27.05.2015 for conducting M.Ed. Programme of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-2016.

4. AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 17.07.2019. The institution has not submitted reply to the Show Cause Notice.

5. AND WHEREAS, the SRC in its 412th Meeting held on 05th & 06th July, 2022 considered the matter and decided to issue last reminder letter to the institution. Accordingly, as per decision of SRC last reminder letter was issued to the institution on 21.07.2022. The institution has not submitted reply to the last reminder letter.

6. AND WHEREAS, the SRC in its 415th meeting held on 03rd – 04th November, 2022 has considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

(i) The institution failed to submit reply to the Last Reminder Letter dated 21.07.2022.

Hence the recognition granted N.S.S. Training College, Pandalam Post, Panthanamthitta District, Kerala-689501 for M.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE

Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn.

7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraw the recognition granted to **N.S.S. Training College, Pandalam Post, Panthanamthitta District, Kerala-689501** for conducting **M.Ed.** programme of two-year duration with an annual intake of 50 students. No fresh admissions are permitted now onwards. However, if any student is pursuing **M.Ed.** programme is allowed to continue till they complete the course.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -


"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day falls or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(8. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।"

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
