WITHDRAWAL ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Y V Rao Siddhartha College of Education, Plot No. 6-150, Kanuru Village, Vasantha Nagar P.O., Vijayawada Rural, Vijayawada City, Krishna District, Andhra Pradesh-520010 run by Siddhartha Academy of General and Technical Education, Plot No. 60-2/1, Siddhartha Nagar, Vijayawada Village, Taluk & City, Krishna District, Andhra Pradesh-520010 vide order no. F.SRO/NCTE/SRCAPP2691/M.Ed./AP/2016-2017/84864 dt. 02.05.2016 for conducting M.Ed. Programme of two years duration with an annual intake of 50 students (1 unit) from the academic sessions 2016-2017.

2. AND WHEREAS, the institution vide letter dated 07.11.2022 has submitted written representation as under: -

"On behalf of Y.V. Rao Siddhartha College of Education sponsored by Siddhartha Academy of General & Technical Education, Vijayawada, Andhra Pradesh, it is respectfully submitted as follows:

Y.V. Rao Siddhartha College of Education, Vijayawada was established in 1983 offering B.Ed. programme with due approval from the Government of Andhra Pradesh and later from NCTE also. M.Ed. course was started from the academic year 2016-2017 with due approval from NCTE (copies enclosed for favor of ready reference). Accordingly, we have been making admissions every year both in B.Ed. and M.Ed. programs in conformity with rules and regulations of both NCTE and Govt. of Andhra Pradesh.

of late, especially from the academic year 2019-2020, the admissions into M.Ed. course took a beating in the state and admissions started falling since then and in the subsequent academic years also. The same trend is continuing and there are almost none to join M.Ed. Course at present. In these circumstances, the Management of this institution decided to seek approval to stop M.Ed. course from the academic year 2022-2023. Please find enclosed a copy of the resolution of the Government Body of the Society seeking permission to stop M.Ed. Course.

In view of the name, we request the authorities of the NCTE to permit Y.V. Rao Siddhartha College of Education, Vijayawada, Andhra Pradesh to discontinue M.Ed. Course effective from the academic year 2022-2023 and also permit withdrawal of fixed Deposit submitted at the time of starting of the course. We would be grateful if our request is approved and communicated at the earliest."



3. **AND WHEREAS**, the SRC in its 421st Meeting held on 10th February, 2023 has considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the Institution vide letter dated 07.11.2022 by withdrawing the recognition granted to Y V Rao Siddhartha College of Education, Plot No. 6-150, Kanuru Village, Basantha Nagar P.O., Vijayawada Rural, Vijayawada City, Krishna District - 520010, Andhra Pradesh for conducting M.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."


4. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Y V Rao Siddhartha College of Education, Plot No. 6-150, Kanuru Village, Basantha Nagar P.O., Vijayawada Rural, Vijayawada City, Krishna District - 520010, Andhra Pradesh run by Siddhartha Academy of General and Technical Education, Plot No. 60-2/1, Siddhartha Nagar, Vijayawada Village, Taluk & City, Krishna District, Andhra Pradesh-520010 for conducting M.Ed. course of two years duration with an annual intake of 50 students (one unit) from the academic session i.e., 2022-2023.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."


"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य



सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
