CONTINUATION ORDER

WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, **P. Narayana Reddy College of Education, No. 420, 450, Plot No. 4, 2nd Street, Pebbair Village, Post, Taluk & City, Mahbubnagar District – 509104, Telangana** vide order no. F.SRO/NCTE/SRCAPP3195/B.Ed/AP/2016-2017/84811 dated 02.05.2016 for conducting B.Ed. course of two year duration with an annual intake of 100 students from the academic session 2016-17.

2. **AND WHEREAS**, the SRC in its 377th meeting held on 03rd – 04th July, 2019 has considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.SRO/NCTE/SRCAPP3195/B.Ed/TS/2019/106835-6840 dated 15.07.2019 was issued to the institution.

3. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F. No. 89-293/E-126920/2019 Appeal/27th Mtg.-2019/27th August, 2019 dated 26.09.2019 appeal remand back the order appealed against. The institution has not submitted reply to the appeal remand back case.

4. **AND WHEREAS**, the SRC in its 381st meeting held on 31st October – 01st November, 2019 has considered the matter and decided to constitute VT. Accordingly, as per the decision of SRC a inspection of the institution was conducted on 12.12.2019 and the VT report received on 23.12.2019.

5. **AND WHEREAS**, the SRC in its 383rd meeting held on 07th to 09th January, 2020 has considered the mater/VTR and decided to issue a letter to the Registrar, Palamuru University. Accordingly, as per the decision of SRC a letter was issued to the Registrar, Palamuru University on 22.01.2020. The Palamuru University has submitted reply by E-mail received on 14.02.2023 and the institution has submitted the documents vide letter dated 17.03.2023.

6. **AND WHEREAS**, the SRC in its 423rd meeting held on 12th April, 2023 considered the matter and decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **P. Narayana Reddy College of Education, Survey No. 420 & 450, Pebbair Grampanchayath Post, Taluk & City, Mahbubnagar District-509104, Telangana** for B.Ed. programme for 2 basic units of 50 students each.

7. **NOW THEREFORE**, this order is issued permitting the institution i.e., **P. Narayana Reddy College of Education, Survey No. 420 & 450, Plot No. 4, 2nd Street, Pebbair Grampanchayath Post, Taluk & City, Mahbubnagar District-509104, Telangana** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **2 basic units of 50 students each** subject to fulfilment of the following conditions:-

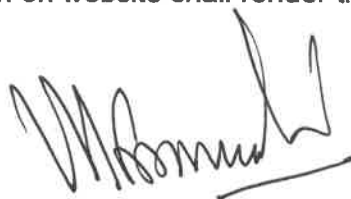
- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.



11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
12. The institution shall make available the list of students admitted on its official website.
13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.

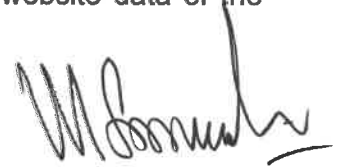
