WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Nethaji College of Education, No. 27, Arehalli, Ittamadu Main Road, Banashankari 3rd Stage, Bangalore, Karnataka-560061 run by Nethaji Smaraka Vidyakendra Trust, Bangalore, Karnataka vide order No. F.SRO/NCTE/B.Ed./2004-2005/8834 dated 30.11.2004 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- AND WHEREAS, the institution in its letter dt. 08.10.2007 has submitted a proposal for 2. shifting of premises along with Rs. 40,000/-towards shifting fee. Inspection was carried out on 25th October, 2010. The SRC in its 198th Meeting held on 24th to 26th November, 2010 considered the VT report and all the relevant documentary evidence and it was decided to issue Show Cause Notice. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 19.01.2011. The institution submitted its written representation on 11.02.2011. Further, the institution has submitted Rs. 40,000/- for change of name from "Nethaji College of Education" to "SJB College of Education."
- AND WHEREAS, the SRC in its 201st Meeting held on 22nd & 23rd February, 2011 considered the written representation and decided to permit the institution to shift to new/permanent premises. In the light of the above, the minutes need to be reviewed. The case was reviewed in 205th Meeting of SRC and the Committee decided not to permit as it involves shifting of institution from one place to another. Under the above norms and logic/rationale. The Committee considered the request of the institution and decided that the request for shifting cannot be complied with and change of Management is also not permissible under NCTE Act and Regulations. The order was issued on 09.08.2010.
- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by 4. consented to come under new Regulations vide a notarized affidavit dated 22.01.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 15.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.
- AND WHEREAS, the SRC in its 292nd Meeting held during 29th & 30th September, 2015 5. has considered the requisition for change of intake and decided to issue corrigendum. As per the decision of SRC, corrigendum No.F.SRO/NCTE/APS01718/B.Ed./KA/2015-16/64848 was issued to the institution on 09.12.2015 for conducting one unit of 50 students.

AND WHEREAS, the matter regarding compliance by the institution of the conditions of the revised recognition order was placed before the SRC in its 369th Meeting held on

28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 25.04.2019.

- 7. **AND WHEREAS,** the SRC in its 375th Meeting of SRC held on 03rd & 04th May, 2019 considered the matter and decided to issue Withdrawal order to the institution. Accordingly, a Withdrawal order vide order no. F.SRO/NCTE/APSO1718/B.Ed./KA/2019/104758-64 dt. 30.05.2019 was issued to the institution. Aggrieved with the order of the SRC, NCTE, the institution filed a W.P. No. 31071 of 2019 before the Hon'ble High Court of Karnataka at Bangalore.
- **8. AND WHEREAS,** the SRC in its 384th Meeting held on 12th & 13th February, 2020 considered the matter and decided to write a letter to the institution asking therein to submit the documents. Accordingly, as per the decision a letter was issued to the institution on 26.02.2020. The institution has submitted reply dated 23.03.2020 & 03.06.2020.
- **9. AND WHEREAS,** the SRC in its 392nd Meeting held on 15th & 16th December, 2020 has considered the matter and decided to issue Withdrawal order to the institution. Accordingly, as per the decision of SRC withdrawal order vide no. F.SRO/NCTE/APSO1718/B.Ed./KA/392nd/2020/122174-2180 dt. 29.12.2020 to the institution.
- **10. AND WHEREAS,** the institution has filed Writ petition no. 20003/2021 before the Hon'ble High Court of Karnataka title as Nethaji College of Education Vs National Council for Teacher Education. The institution has submitted its reply dt. 22.08.2022 & dt. 12.10.2022.
- 11. AND WHEREAS, the SRC in its 422^{nd} meeting held on $02^{nd}-03^{rd}$ March 2023 considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 17.03.2023. The institution vide dated 10.04.2023 has submitted a reply to the Final Show Cause Notice.
- **12. AND WHEREAS,** the SRC in its 423rd meeting held on 12th April 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution namely Nethaji College of Education decided that shifting of premises be permitted to the institution at new address i.e. Survey No. 67, Dr. Vishnuvardhan Road, B.G.S. Health & Education City, Kengeri, Bangalore South Taluk, Karnataka-560060. The Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 1 basic unit of 50 students".

NOW THEREFORE, this order is issued permitting the institution i.e. Nethaji College of Education, No. 27, Arehalli, Ittamadu Main Road, Banashankari 3rd Stage, Bangalore, Karnataka-560061 to shift its building at new address at Survey No. 67, Dr. Vishnuvardhan Road, B.G.S. Health & Education City, Kengeri, Bangalore South Taluk,

Karnataka-560060 run by Nethaji Smaraka Vidyakendra Trust, Bangalore, Karnataka for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **14.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **15.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 16. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last guarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.

- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 17. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 18. The institution shall make available the list of students admitted on its official website.
- 19. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
