WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely St. Marys College of Education, Vizianagaram Revenue Division Garividi Vizianagaram Dsitrict-535101 Andhra Pradesh vide order No. F.AP/NCTE/B.Ed/258/SRO /NCTE/2002-2003 dated 03.03.2003 for conducting (B.Ed.) Course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 12.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 considered the matter and decided to issue SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a Show Cause Notice was issued to the institution on 08.11.2019. The institution did not submit any reply of Show Cause Notice.
- **4. AND WHEREAS,** the SRC in its 393rd meeting held on 05th 06th January, 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 11.01.2021. The institution did not submit any reply of Final Show Cause Notice.
- **5. AND WHEREAS,** the SRC in its 412th meeting held on 05th 06th July, 2022 has considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.SRO/NCTE/APSO0263/B.Ed./AP/2022 /132969-132973 dated 25.07.2022 was issued to the institution.
- 7. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-258/E-280879/2022Appeal/10th Meeting, 2022/116041 dated 21.12.2022 appeal remand back the order appealed against. The institution vide letter dated 05.01.2023 submitted reply to the appeal remand back order.

- **8. AND WHEREAS,** the SRC in its 421st meeting held on 10th February 2023 considered the matter and Committee decided to issue a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 14.02.2023. The institution has submitted reply vide letter dated 03.04.2023.
- 9. AND WHEREAS, the SRC in its 423rd meeting held on 12th April 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution St. Marys College of Education, Survey No. 174, Cheepupalli, Garividi, Vizianagaram Dsitrict-535101 Andhra Pradesh for B.Ed. programme for 2 basic units of 50 students each."

- 10. NOW THEREFORE, this order is issued permitting the institution i.e. St. Marys College of Education, Survey No. 174, Cheepupalli, Garividi, Vizianagaram Dsitrict-535101 Andhra Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic unit) of 50 students each subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

- **12.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **14**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- **15.** The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.
