#### WITHDRAWAL ORDER

WHEREAS, the recognition u/s 15(3)(a) of NCTE Act, 1993 was granted to the institution namely Kavery Teacher Training Institute, Mercheri, Mettur, Salem District, TamilNadu run by The Kavery Educational Trust, M.Kalipatti, Mechari-636453. Salem District, TamilNadu for D.T.Ed programme as per following details:-

- (i) The SRC vide Order No. F F.TN/SRO/NCTE/2005-2006/3368 dated 07.10.2005 for conducting D.T.Ed. programme of two years duration with an annual intake of 50 students from the academic session 2005-2006.
- (ii) The SRC vide Order No. F.TN/SRO/NCTE/2006-2007/7230 dated 14.08.2006 for conducting D.T.Ed. (Additional Intake) programme of two years duration with an annual intake of two units of 50 students from the academic session 2006-2007.
- (iii) The SRC vide Order No. F.SRO/NCTE/2007-2008/4385 dated 30.08.2008 for. conducting D.T.Ed. (Additional Intake) programme of two years duration with an annual intake of two units of 50 students.
- 2. AND WHEREAS, an email dated 17.05.2023 was received from the institution for closure.
- AND WHEREAS, the SRC in its 425th Meeting of SRC held on 18th May 2023 considered the matter for closure of the D.T.Ed. Programme & D.T.Ed. (Additional Intake) and decided as under: -

"The original files of the Institution along with other related documents. NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the Management/nstitution vide letter dated 18.05.2023 by withdrawing the recognition granted to Kavery Teacher Training Institute, Mercheri, Mettur. Salem District, TamilNadu for conducting D.T.Ed., D.T.Ed.-Al, D.T.Ed.-Al. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023. olc

The FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC".

- 4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Kavery Teacher Training Institute, Mercheri, Mettur, Salem District, TamilNadu for conducting D.T.Ed., D.T.Ed.-A.I. & D.T.Ed.-A.I. Programme of two years duration from the academic session i.e. 2022-2023 onwards.
- 5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(5. इसके अलावा, संस्था और संबद्घ निकाय को एनसीटीई अधिनियम, 1993 की धारा 17(4) के निम्नितिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte.gov.in">www.ncte.gov.in</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
