WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Jawaharlal Nehru College of Education, Survey No. 1543, Vemulawada Gramapanchath, Karimnagar District, Andhra Pradesh-505302 (Now Telangana) vide order No.F.AP/SRO/NCTE/2002-03/1187 dated 21.06.2002 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 22.01.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 29.05.2015 for conducting **B.Ed. Programme** of two years duration with an annual intake of 100 students of two basic units from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 317<sup>th</sup> meeting held on 28<sup>th</sup> to 30<sup>th</sup> July 2016 has considered the matter and the Committee decided to issue a Show Cause Notice. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 07.09.2020.
- **4. AND WHEREAS**, the SRC in its  $393^{rd}$  meeting held on  $05^{th}-06^{th}$  January 2021 and the Committee considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of the SRC Final Show Cause Notice was issued to the institution on 11.01.2021. The institution has submitted a reply to Final Show Cause Notice on 22.01.2021.
- 5. AND WHEREAS, the SRC in its 399<sup>th</sup> Meeting held on 22<sup>nd</sup> & 23<sup>rd</sup> April, 2021 has considered the matter and decided to constitute the **Visiting Team** for shifting of premises. Accordingly, as per the decision of SRC VT constitute date 05.07.2021 and <u>Visit Schedule on 15.07.2021 to 04.08.2021 but the institution has submitted an email for request to postpone virtual inspection of the institution. Another inspection visit schedule dated 04.10.2021 from 14.10.2021 to 03.11.2021. The inspection of the institution was conducted on 21.06.2023 and VT report submitted on 22.06.2023. The institution has submitted documents through an e-mail dt. 22.06.2023.</u>
- **6. AND WHEREAS**, the SRC in its 427<sup>th</sup> meeting held on 20<sup>th</sup> July 2023 has considered the matter and decided to issue a Show Cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 01.08.2023. The institution vides letter 30.07.2023 and 23.08.2023 has submitted a reply to the Show Cause Notice.
- 7. AND WHEREAS, the SRC in its 428<sup>th</sup> meeting held on 25<sup>th</sup> August 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made:

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Jawaharlal Nehru College of Education, Survey No. 1543, Vemulawada Gramapanchath, Karimnagar District, Telangana-505302 for B.Ed. programme for 2 basic units of 50 students each".

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. Jawaharlal Nehru College of Education, Survey No. 1543, Vemulawada Gramapanchath, Karimnagar District, Telangana-505302 run by Jawaharlal Nehru Education Society, Vemulawada-505302, Karimnagar District, Telangana for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of 2 basic unit of 100 students subject to fulfilment of the following conditions:-
  - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **10.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities:

- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
