WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Velankanni College of Education, Khandrika Village-524320, Venkatachalam (M), Nellore District, Andhra Pradesh run by Velankanni Educational Society. Rajaka Street, Nellore, Andhra Pradesh vide order No. F. SRO/NCTE/AP/B.Ed./2004-2005/1564 dated 04.07.2005 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 21.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units of 50 students each) from the academic session 2015-16.
- **AND WHEREAS,** the SRC in its 381st meeting held on 31st October 01stNovember. 2019 considered the matter and decided to issue First Show Cause Notice u/s 17 of the NCTE Act issued to the institution to submit its representation/ reply to the observation noted by the Regional Committee. Accordingly, a First Show Cause Notice was issued to the institution on 26.11.2019. The institution submitted its reply to the First Show Cause Notice vide letter dated 02.01.2020.
- AND WHEREAS, the matter placed before the SRC in its 390th meeting held on 28th - 29thOctober, 2020 considered the matter and Committee decide to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 03.11.2020. The institution has not submitted reply.
- AND WHEREAS, the SRC in its 395th meeting held on 25th 26th February 2021 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No.F.SRO/NCTE/APS02909/B.Ed./AP/2021/124619-124626 was issued to the institution on 08.03.2021.
- AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-224/E-193147/2021 Appeal/20th Meeting, 2021 Appeal No.APPLSRC202114060 dated 04.10.2021 and the Appeal Committee decided to be rejected and the order of the SRC is confirmed.
- AND WHEREAS, the applicant institution moved a writ petition before the Hon'ble 7. High Court of Andhra Pradesh (Amravati) bearing in W.P. 1413√2023 titled Velankanni

College of Education Vs National Council for Teacher Education & Anr, the Hon'ble High Court vide its order dated 26.06.2023 issued directed that "the present Writ Petition can be disposed of directing the petitioner to submit all the documents enclosed along with the representation dated 10.04.2023 within a period of one week. On receipt of such documents and on perusal of the same, the respondents, more particularly, respondent No. 2 to 4 are directed to considered the same and pass appropriate orders within a period of three (03) weeks from the date of receipt of a copy of this order".

- 8. AND WHEREAS, in compliance of the order of Hon'ble High court of Andhra Pradesh, the Appellate Authority has passed an order No. 89-224/E-193147/2021 Appeal/8th Meeting, 2023 Appeal No.APPLSRC202114060 dated 17.08.2023 and decided to remand back the case to SRC.
- 9. **AND WHEREAS**, the SRC in its 428th meeting held on 25th August 2023 considered the inspection report for shifting premises as decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Velankanni College of Education, Survey No. 657/1, Khandrika Village, Venkatachalam Panchayat, Nellore District, Andhra Pradesh for B.Ed. programme 2 basic units of 50 students each."

- 10. NOW THEREFORE, this order is issued permitting the institution i.e. Velankanni College of Education, Survey No. 657/1, Khandrika Village, Venkatachalam Panchayat, Nellore District, Andhra Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-
 - 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- 11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **12.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students:
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **14**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself
