WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Gokul College of Education, Gokul Nagar Colony, Nalgonda District-508001, Andhra Pradesh vide order No. F. AP/B.Ed./36/SRO/NCTE/2000-2001/1274 dated 14.07.2000 for conducting B.Ed. Course of one-year duration with an annual intake of 160 students from the academic session 2000-2001.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units of 50 students each) from the academic session 2015-16.
- AND WHEREAS, a Corrigendum was issued to the institution vide order no. 3. F.SRO/NCTE/AOSO0192/B.Ed./AP/2015/68260 dated.24.06.2015 with an annual intake of 150 for three basic units from the academic session 2015-16.
- AND WHEREAS, the SRC in 388th meeting held on 14th 15th 2020 considered 3. the matter and decided that SCN issued to all such institutions which have not submitted compliance. Accordingly, A Show Cause Notice was issued to the institution on 13.04.2021. The institution has not submitted reply to the Show Cause Notice.
- AND WHEREAS, the SRC in its 406th meeting held on 19th January 2022 has considered the matter and decided to Final Show cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 04.02.2022. The institution has not submitted reply.
- AND WHEREAS, the SRC in its 414th meeting held on 26th 27th September 2022 has considered the matter and decided to issue a Last Reminder Letter. Accordingly, as per the decision of SRC, a Last Reminder Letter was issued to the institution on 12.10.2022. The institution vide letter dated 21.10.2022 ha submitted a reply to the Last Reminder Letter.
- AND WHEREAS, the SRC in its 415th meeting held on 03rd & 04th November 6. 2022 has considered the matter and decided to Withdraw the Recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No.F.SRO/NCTE/AOS00192/B.Ed. /TS/2022 /136820-136824 dated 16.11.2022 was issued to the illustitution.

- 7. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-98/E-304446/2023 Appeal/7th Meeting, 2023 Appeal No.APPLSRC202314600 dated 13.07.2023 appeal remand back the order appealed against. The institution has submitted a reply to Appeal Remand Back on 27.07.2023.
- **8. AND WHEREAS,** the SRC in its 428th meeting held on 25th August 2023 considered the inspection report for shifting premises as decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Gokul College of Education, Survey No. 612, Munugode by pass Road, Village Mamilla Gudem, (M.O. 7 Dist) Nalgonda-508001, Telangana for B.Ed. programme 2 basic units of 50 students each."

- 9. NOW THEREFORE, this order is issued permitting the institution i.e. Gokul College of Education, Survey No. 612, Munugode by pass Road, Village Mamilla Gudem, (M.O. 7 Dist) Nalgonda-508001, Telangana for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **10.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.



- 11. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **13**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 14. The institution shall make available the list of students admitted on its official website.
- 15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the
