ORDER

WHEREAS, the institution Mother Gnanamma Catholic College of Education, Plot/Khasara No. 55/1, 42-3A & 42-3B, Madathattuvilai Main Road, Ward No.1, Villukuri Village and Post Office, Villukuri City Kalkulam Taluk, Kanyakumari District, Tamilnadu-629180 was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/SRCAPP1807/B.Ed./TN/2015/62187 dt. 03.03.2015 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2015-2016.

AND WHEREAS, the Tamilnadu Teachers Education University had forwarded a copy of show cause notice issued to the institution for not functioning in accordance with the conditions stipulated by the NCTE, SRC, Bangalore and Tamilnadu Teachers Education University as could be apprehended from the report of Inspection commission which caused a surprise visit to the colleges.

AND WHEREAS, the SRC in its 388th Meeting held on 14th & 15th October 2020 and decided to issue a Show Cause Notice (SCN) to the written representation to the condition mentioned therein. As per the decision of SRC, a Show Cause Notice was issued to the institution on dt. 24.09.2020. A reply of Show Cause Notice was received on dt. 29.01.2020.

AND WHEREAS, the matter was placed before the SRC in its 389th meeting held on 12th & 14th October, 2020 considered and decided as the following grounds:

“The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution the Committee decided that the continuation order be issued to the Institution Mother Gnanamma Catholic College of Education, Villukuri Village, Tamil Nadu for B.Ed programme for 2 basic unit of 50 students each.”

NOW THEREFORE, this order is issued permitting the institution i.e. **Mother Gnanamma Catholic College of Education, Plot/Khasara No. 55/1, 42-3A & 42-3B, Madathattuvilai Main Road, Ward No.1, Villukuri Village and Post Office, Villukuri City Kalkulam Taluk, Kanyakumari District, Tamilnadu-629180** for continuation of recognition for B.Ed. programme for 2 basic units of 50 students each unit subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
1. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.
 2. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
 3. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
