ORDER

WHEREAS, the recognition was granted to the institution namely S. Preethi M.Ed. College of Women, S. No. 201/1, 201/2A, 201/2C, 201/3 Arasanoor, Thirumansolai Post, Sivagangai Taluk, Sivagangai District, Tamilnadu-630601 run by Augustine Educational and Charitable Trust, Arasanoor, Thirumansolai Post, Sivagangai District, Tamilnadu-630601 on dt. 03.03.2014 for conducting M.Ed. course of one-year duration with an annual intake of 35 students.

AND WHEREAS, the Tamilnadu Teachers Education University had forwarded a copy of show cause notice issued to the institution for not functioning in accordance with the conditions stipulated by the NCTE, SRC, Bangalore and Tamilnadu Teachers Education University as could be apprehended from the report of Inspection commission which caused a surprise visit to the colleges.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits affidavit submitted by the institution on dt. 23.01.2015 and the provisional revised recognition order was issued to the institution on dt. 30.05.2015 for M.Ed. course for conducting two years duration with an annual intake of 50 students (one unit) from the academic session 2015-2016.

AND WHEREAS, the institution submitted compliance against RPRO issued in respect of B.Ed. course vide letter dt. 31.07.2015 for M.Ed. course. The matter was again placed before the SRC in its 384th meeting held on 12th - 13th February 2020 and the Committee was decided to withdrawal the institution for following grounds: -

1. The Management of the Institution had not submitted required documents in response to letter issued to the Institution on dt. 13.06.2016. Another opportunity was given tot eh institution by serving a Final Show Cause Notice dt. 15.11.2019. The institution vide letter dt. 05.12.2019 submitted its reply/representation in response to Final Show Cause Notice. On perusal of the same the Committee found the following defects/shortcomings/deficiencies as per provisions of the NCTE Regulations, 2014 which are as under:

- 2. The institution has only submitted xerox copy of FDRs of Rs. 7 Lakhs + Rs. 3 Lakhs.
- 3. The institute has submitted a letter dt. 22.07.2015 approved by TTEU, Registrar for B.Ed. course (P-511-512/Coors./B.Ed.) and letter dt. 26.02.2016 (P-508/Coors./B.Ed.) faculty list of One Principal +12 Assistant Professor + One Performing Arts + One Assistant Professor + One faculty of Fine Arts.
- 4. The institution has submitted a letter dt. 26.02.2016 (P-508/Coors/B.Ed.) and dt. 08.02.2018 (P-494/Coors./B.Ed.) approved by the TTEU, Registrar for faculty profile for M.Ed. course One Principal/HoD + Six Assistant Professors + Three Assistant professor + One Faculty for Fine Arts.
- 5. The faculties namely K. Arumugam (Assistant Professor), A. Kottairaj (Assistant Professor), P. Ravikumar (Assistant Professor), G. Sivakumar (Assistant Professor), S. Pushpa (Assistant Professor), P. Viji (Assistant Professor), R. Shanthi (Assistant Professor), S. Arockiamary (Assistant Professor), A. Daisy (Assistant Professor), A Vijayalakshmi Assistant) are not qualified as per NCTE, Regulations.

Hence, the Committee decided to withdraw the recognition granted to S. Preethi B.Ed. College, Arasanoor, Sivagangai Road, Sivagangai District, Tamilnadu-62560 for conducting B.Ed. & M.Ed courses w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Accordingly, a withdrawal order was issued to the institution vide letter dt.27.02.2020. Thereafter, the institution preferred an appeal u/s 17 of NCTE Act, 1993 and the Appellate Authority vide order No. F.No.89-129/E-159298/2020 Appeal/17th Mtg.-2020/01st September, 2020/93581 dt.29.09.2020 remanded back the matter to SRC. The operative part of the order is as under:-

"AND WHEREAS Appeal Committee decided that appellant institution is required to submit within 15 days of the issue of appeal order to SRC. (i) original valid FDRs, (ii) List of faculty, (iii) Bank Statement to SRC. Appeal Committee further decided to remand back the case to SRC for revisiting the matter.

AND WHEREAS after perusal of the Memoranda of Appeal, affidavit, documents on record and online submission made by appellant on 01/09/2020. Appeal Committee concluded to remand back the case to SRC for revisiting the matter."

AND WHEREAS, the institution vide letters dt.06.10.2020 had submitted the documents.

AND WHEREAS, the matter was placed before the SRC in its 389th meeting held on 12th & 14th October, 2020 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution vide letter dt 06.10.2020, the Committee decided that the continuation order be issued to the Institution S. Preethi B.Ed. College, 201/1, 2A,3, Arasanoor, Thirumansolai Post, Sivagangai Road, Sivagangai Taluk, Sivagangai District – 625601, Tamilnadu for the following courses:

- (i) B.Ed 2 units (50 students each unit).
 - (ii) M.Ed-1 unit of 50 students."

NOW THEREFORE, this order is issued permitting the institution i.e. S. Preethi B.Ed. College, 201/1, 2A,3, Arasanoor, Thirumansolai Post, Sivagangai Road, Sivagangai Taluk, Sivagangai District – 625601, Tamilnadu for continuation of recognition for M.Ed. programme for one unit of 50 students subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 1. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.
- 2. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- 3. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 4. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 5. The institution shall make available the list of students admitted on its official website.
- 6. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rule. Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
