WHEREAS, Jnana Vikas Foundation, Ramnagaram, Bangalore Rural District, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Jnana Vikas College of Educaion, B.M. Road, Bidadi Ramanagaram Taluk, Bangalore Rural Distric – 562109, Karnataka offering Secondary(B.Ed) course of One year duration with an annual intake of 100 students from academic session 2005-2006 under Section 14 (1) of the NCTE Act, 1993. Recognition order was issued to the institution on 06.01.2006.

AND WHEREAS, a letter was issued to the institution regarding notification of new Regulations 2014 seeking consent on their willingness for fulfilling the revised Norms and Standards on 31.05.2015 and the institution has not submitted the Affidavit.

AND WHEREAS, the SRC in its 294th meeting held on 14th – 16th November, 2015 and the committee considered the matter and noticed that the institution has not submitted affidavit adhering to Regulations 2014 and hence not issued Revised Orders and decided to issue Show Cause Notice for withdrawal of recognition under NCTE act for the following deficiency:-

• Affidavit not submitted affirming adherence to Regulations, 2014.

AND WHEREAS, accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 14.06.2016. But, till date the institution has not submitted the Show Cause Notice reply.

AND WHEREAS, the SRC in its 359th meeting held during 17th - 18th May, 2018 considered the Non-Submission of SCN reply and decided as under:-

- "1. Submission of an Affidavit expressing willingness to adhere to the 2014 Regulations is essential for old cases to be considered as RPRO cases.
- 2. Failure to submit the Affidavit is therefore a grave deficiency.
- 3. We can not wait indefinitely for their reply to our SCN dt. 14.6.16.
- 4. Withdraw the recognition given by us to their B.Ed (2 units).
- 5. Return the FDRs.
- 6. Close the file.
- 7. Inform the University."

NOW THEREFORE, the recognition of Jnana Vikas College of Educaion, B.M. Road, Bidadi Ramanagaram Taluk, Bangalore Rural Distric – 562109, Karnataka for B.Ed (APS01691) programme is hereby withdrawn w.e.f 2018-19.
