# TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Nanjamma Teacher Training Institute, Navodaya Vidya Samsthe, Kuruboor, Mylandla Post, Chintamani Taluk, Kolar District, Karnataka-563125 run by Navodaya Educational Trust, Kolar District, Karnataka vid order no. F.SRO/NCTE/D.Ed./2004-2005/8881 dt. 30.11.2004 for conducting Elementary (D.Ed.) course of two and half year's duration from the academic session 2004-05 with an annual intake of 50 students.

- 2. AND WHEREAS, a Compliant letter was received from Sri B.R. Ramesh, advocate, 895, 3<sup>RD</sup> 'A', Main, 'D' Block, ii Stage, Rajajinagar, Bangalore-560010 regarding the substandard and non-viable institutions of teachers training in Chickballapur district. A copy of the evaluation report of 9 D.Ed. colleges during the year 2009-2010 was enclosed along with the complaint letter.
- 3. AND WHEREAS, the SRC in its  $248^{th}$  meeting held on  $13^{th} 15^{th}$  July, 2013 has considered the matter and all the relevant documentary evidence and it was decided to issue a Show Cause Notice. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 27.08.2013. The institution did not submit any reply to Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 415<sup>th</sup> meeting held on 03<sup>rd</sup> 04<sup>th</sup> November, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 21.11.2022. The institution did not submit reply of Final Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 421st Meeting held on 10th February, 2023 has considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

(i) The institution failed to submit reply to the Final Show Cause Notice dated 21.11.2022.

Hence the recognition granted Nanjamma Teacher Traning Institute, Navodaya Vidya Samsthe, Kuruboor, Mylandla Post, Chintamani Taluk, Kolar District-563125, Karnataka for D.Ed. programme is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing D.Ed. programme is allowed to continue till, they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.

However, the FDRs towards Reserve Fund and Endowment Fund/No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws the recognition granted to Nanjamma Teacher Traning Institute, Navodaya Vidya Samsthe, Kuruboor, Mylandla Post, Chintamani Taluk, Kolar District-563125, Karnataka run by Navodaya Educational Trust, Navodaya Vidya Samsthe, Kuruboor, Mylandla Post, Chintamani Taluk, Kolar District-563125, Karnataka for conducting D.Ed. programme of two and half year's duration with an annual intake of 50 students. No fresh admissions are permitted now onwards. However, if any student is pursuing D.Ed. programme is allowed to continue till, they complete the course.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

- (7. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: "यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमित प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")
- 8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
