WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely R.B.V.R.R. College of Education, Seethampur, Arepalli Post, Karimnagar, Andhra Pradesh-505002 run by R.B.V.R.R Vignana Parishad, Karimnagar, Andhra Pradesh vide order no. F.AP/B.Ed./SRO/NCTE/2004-2005/803 dt. 23.02.2005 for conducting Secondary (B.Ed.) course of one year duration from the academic session 2004-2005 with an annual intake of 100 students.

- 2. AND WHEREAS, the recognition of the institution was withdrawn by the SRC vide order no. F.SRO/NCTE/Ref/2008-09/5858 dated 06.10.2008. Further, a corrigendum was issued to the institution vide corrigendum no. F.SRO/NCTE/B.Ed/2009-2010/17524 dated 25.01.2010 in which it was mentioned that instead of words "Academic session 2008-2009" may be read as "Academic session 2010-2011"
- 3. AND WHEREAS, the SRC in its 196<sup>th</sup> meeting held on 15<sup>th</sup>-16<sup>th</sup> September 2010 considered the matter and decided to continue the recognition of the institution. Accordingly, as per the decision of SRC, the recognition accorded to the institution was continued vide order no. F.SRO/NCTE/2010-2011/21205 dated 20.09.2010.
- 4. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 16.01.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 Students (two basic units) from the academic session 2015-16.
- 5. AND WHEREAS, the SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> Oct & 01<sup>st</sup> Nov, 2019 has considered the matter and the decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report not accompanied with the requisite documents. Accordingly, as per the decision of SRC First Show Cause Notice was issued to the institution dt. 19.11.2019. The institution has submitted a written representation dt. 08.02.2023.
- 6. AND WHEREAS, the SRC in its 425<sup>th</sup> Meeting held on 18<sup>th</sup> May 2023 has considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution dt. 26.05.2023. The institution has submitted reply of Final Show Cause Notice on 12.07.2023.

7. **AND WHEREAS**, the SRC in its 427<sup>th</sup> Meeting held on 20<sup>th</sup> July, 2023 has considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution R.B.V.R.R. College of Education, Survey No. 15, Seethampur, Arepalli Post, Karimnagar, Telangana for B.Ed. programme for 2 basic units of 50 students each."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e., R.B.V.R.R. College of Education, Survey No. 15, Seethampur, Arepalli Post, Karimnagar, Telangana-505002 run by Raja Bahadur Venkata Rama Reddy Vighyana Parishad, Seetharampur, Karimnagar, Telangana-505002 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 9. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
