**CONTINUATION ORDER**

WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Jain Mahila Mandal's Women's College of Education, Behind Hindustan Petroleum Office, Subhas Chandra Nagar, Tilakwadi 3<sup>rd</sup> Gate, Belgaum, Karnataka-590006 run by Jain Mahila Mandal's Mahila Shikshan Maha Vidyalay, Belgaum, Karnataka vide order No. F.KR/Sec/SRO/NCTE/2001-02/9352 dated 17.01.2002 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2001-2002.

2. AND WHEREAS, a shifting order was issued vide order no. F.KR/B.Ed./51/SRO/NCTE/2002-03/3326 dt. 14.11.2002 for granted recognition to Mahila Mandal's Women's College of Education, Behind Hindustan Petroleum Office, Subhas Chandra Nagar, Tilakwadi 3<sup>rd</sup> Gate, Belgaum, Karnataka-590006 for B.Ed. course of one year duration from the academic session 2002-2003 with an annual intake of 100 students.

3. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 14.01.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 16.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.

3. AND WHEREAS, the SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> Oct & 01<sup>st</sup> Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in responds to RPRO issued by the SRC. Accordingly, as per the decision of SRC First Show Cause Notice was issued to the institution on 06.11.2019. The institution did not submit any reply to First Show Cause Notice.

4. AND WHEREAS, the Southern Regional Committee (SRC) in its 412<sup>th</sup> meeting held on 5<sup>th</sup> & 6<sup>th</sup> July, 2022 took note about non-functioning of the website of the institutions which is mandatory requirement as per NCTE Regulations, 2014. In view of the non-compliance, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per decision of the SRC,

13 points Show Cause Notice was issued to the institution on 14.09.2022. The institution has submitted its reply on 04.10.2022.

5. **AND WHEREAS**, the SRC in its 415<sup>th</sup> meeting held on 03<sup>rd</sup> – 04<sup>th</sup> November 2022 considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 21.11.2022. The institution vide dated 25.11.2022 has submitted a reply to the Final Show Cause Notice. An email dated 08.05.2023 has submitted a reply to the Final Show Cause Notice.

6. **AND WHEREAS**, the SRC in its 425<sup>th</sup> meeting held on 18<sup>th</sup> May 2023 considered the matter and decided as under:-

***“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -***

***The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Jain Mahila Mandal's Women's College of Education, Survey No. 673, Subhas Chandra Nagara, Tilak Wadi 3<sup>rd</sup> Gate, Belagavi District, Karnataka-590006 for B.Ed. programme for 2 basic units of 50 students each”.***

7. **NOW THEREFORE**, this order is issued permitting the institution i.e. Jain Mahila Mandal's Women's College of Education, Survey No. 673, Subhas Chandra Nagara, Tilak Wadi 3<sup>rd</sup> Gate, Belagavi District, Karnataka-590006 run by Jain Mahila Mandal's Mahila Shikshan Maha Vidyalay, Belgaum, Karnataka for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of 2 basic units of 100 students subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.



8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.


10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

12. The institution shall make available the list of students admitted on its official website.

13. The institution shall fill the information on GIS Portal on the NCTE Website.


