WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Nutan Vidyalaya Society's College of Education, N.V.Complex, Brahampur, Gulbarga-585103, Karnataka run by Nutan Vidyalaya Society's College of Education, N.V.Complex, Brahampur, Gulbarga-585103, Karnataka vide order No. F.SRO/NCTE/B.Ed./2004-2005/9076 dated 02.12.2004 for conducting Secondary B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 02.02.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 16.05.2015 for conducting **B.Ed. Programme** of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.
- 3. AND WHEREAS, the institution has submitted a letter on 27.07.2015 requesting for change to one unit with existing infrastructure, staff member, Endowment and reserve fund. A corrigendum was issued to the institution for one unit on 31.07.2015.
- **4. AND WHEREAS,** the SRC in its 351st meeting held during 28th & 29th December, 2017considered the request of the institution and decided to issue a Show Cause Notice. As per the decision of SRC, a Show Cause Notice was issued to the institution on 05.01.2018. The institution did not submit any reply to the Show Cause Notice.
- **5. AND WHEREAS,** the SRC in its 371st meeting held on 25th & 26th February 2019 considered the matter and committee decided to withdraw the recognition. Accordingly, as per the decision of SRC a withdrawal order No. F.SRO/NCTE/APS02124/ B.Ed./ka/2019/101948-954 was issued to the institution on 06.03.2019.
- **6. AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. F.No.89-193/E-117945/2019 Appeal/3rd Mtg.-2023 dated 07.03.2023 appeal remand back the Order appealed against. The institution did not submit any reply to the Appeal Remand Back.
- 7. AND WHEREAS, the SRC in its 423rd meeting held on 12th April 2023 considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 21.04.2023. The institution vide letter dated 15.05.2023 has submitted a Final Show Cause Notice.
- 8. AND WHEREAS, the SRC in its 425th meeting held on 18th May 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made:

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order beginsued to the Institution Nutan Vidyalaya Society's College of Education, Survey No. 41, Ward No. 36, S B Temple Court Road, Zonal-2, Zonal Commissioner, Kalaburagi-585103, Karnataka for B.Ed. programme for 2 basic units of 50 students each".

- 9. NOW THEREFORE, this order is issued permitting the institution i.e. Nutan Vidyalaya Society's College of Education, Survey No. 41, Ward No. 36, S B Temple Court Road, Zonal-2, Zonal Commissioner, Kalaburagi-585103, Karnataka run by Nutan Vidyalaya Society's College of Education, N.V.Complex, Brahampur, Gulbarga-585103, Karnataka for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of 2 basic units of 100 students subject to fulfilment of the following conditions:-
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **10.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **11.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. - i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 14. The institution shall make available the list of students admitted on its official website.
- 15. The institution shall fill the information on GIS Portal on the NCTE Website.
