WHEREAS, the recognition was granted to the institution namely, Sri Sangameshwar D.Ed. College, Sri Sangameshwar Vidya Vardhak Sanga, Kolhar, Basavana Bagewadi Taluk, Bijapur Dt – 586210, Karnataka for (Elementary)D.Ed. programme vide Order No F.SRO/NCTE/D.Ed/2005-2006/4884 dt. 22.12.2005 for Elementary D.Ed. course of two and half years duration with an annual intake of 50 students from the academic sessions 2005-2006.

2. **AND WHEREAS**, the institution has submitted written representation vide email dated 02.07.2024 to close the D.Ed programme.

3. AND WHEREAS, the SRC in its 440^{th} Meeting held on $03^{rd} - 04^{th}$ July, 2024 considered the request for close the D.Ed. Programme matter and decided as under:

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee agreed to close down the institution as requested by the Institution vide letter dated 02.07.2024 by withdrawing the recognition granted to Sri Sangameshwar D.Ed. College, Sri Sangameshwar Vidya Vardhak Sanga, Kolhar, Basavana Bagewadi Taluk, Bijapur Dt – 586210, Karnataka for conducting D.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

The FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Sangameshwar D.Ed. College, Sri Sangameshwar Vidya Vardhak Sanga, Kolhar, Basavana Bagewadi Taluk, Bijapur Dt – 586210, Karnataka for conducting D.Ed. programme of two and half years duration with an annual intake of 50 students under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

Office: G-7 Sector-10, (Near Sector-10 Metro Station), Dwarka, New Delhi – 110075 E-mail: src@ncte-india.org "If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <u>www.ncte-india.org</u> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
