WHEREAS, recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely, **Dr. Rajabather Tagore Women Teacher Training College, No. 88-E, Gingee Road, Tindivanam-604001, Tamilnadu** vide Order No. F.SRO/NCTE/B.Ed./2007-2008/11395 dated 06.01.2006 for conducting B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2005-2006.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution has submitted willingness affidavit as per Regulation 2014 on 02.03.2015 and the Revised Provisional Recognition Order (RPRO) was issued to the institution on 12.05.2015.
- 3. **AND WHEREAS**, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> 15<sup>th</sup> September 2020 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order was issued to the institution on 21.09.2020.
- 4. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No.89-81/E-178173/2021 Appeal/22<sup>nd</sup> Meeting, 2021 dt. 26.11.2021, the Appeal Committee of the Council concluded that SRC was justified in withdrawing recognition and therefore, the appeal deserved to be rejected and order of the SRC is confirmed.
- 5. **AND WHEREAS**, the institution has filed Writ Petition before Hon'ble High Court of Delhi bearing W.P. (C) No. 9259/2022 titled as Dr. Rajabather Tagore Women Teacher Training College V/s National Council for Teacher Education & Anr, whereby the Hon'ble High Court has directed that: -

"At this stage, counsel for the Petitioner makes a request that an Inspection of the Petitioner-institute be carried out by the Southern Regional Committee, which request is accepted by Mr. Govind Manoharan, who states that the same shall be done within a period of six weeks from today.

Re-notify on 19th September, 2022."

- 6. AND WHEREAS, the SRC in its 412<sup>th</sup> meeting held on 05<sup>th</sup> -06<sup>th</sup> July 2022 has considered the matter and decided to issue a letter to the institution. Accordingly, a letter was issued to the institution on 26.07.2022, to submit Rs. 1,50,000/- (One lakh Fifty Thousand only) towards inspection fee for inspection of its new premises within 21 days from the date of issuance of this letter.
- 7. AND WHEREAS, the inspection was conducted on 25.05.2023 and Vt report received on 25.05.2023.
- **8. AND WHEREAS**, the SRC in its 430<sup>th</sup> Meeting held on 1<sup>st</sup> December, 2023 considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC, a Show Cause Notice was issued on 21.12.2023. The institution submitted its reply on 09.01.2024.
- 9. AND WHEREAS, the SRC in its 436<sup>th</sup> meeting held on 2<sup>nd</sup> & 3<sup>rd</sup> May, 2024 considered the matter and decided to issue shifting order. Accordingly, as per the decision of SRC a shifting order no. F.No.SRC/NCTE/APSO4272/B.Ed /436<sup>th</sup>/TN /2024/144910-144913 dated 14.05.2024 was issued to the institution.
- **10. AND WHEREAS,** the SRC in its 440<sup>th</sup> meeting held on 03<sup>rd</sup> 04<sup>th</sup> July, 2024 considered the matter and decided as under:-

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Dr. Rajabather Tagore Women Teacher Training College, RS No. 12/1, Kilgudalore Village & Panchayat, Ollakore Panchayath Union, Tindivanam Taluk, Villupuram District-604307, Tamilnadu for B.Ed. programme 1 basic unit of 50 students."

- 11. NOW THEREFORE, this order is issued permitting the institution i.e., Dr. Rajabather Tagore Women Teacher Training College, RS No. 12/1, Kilgudalore Village & Panchayat, Ollakore Panchayath Union, Tindivanam Taluk, Villupuram District-604307, Tamilnadu for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 12. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 13. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information if it so desires.

k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

15. The institution shall adhere to the mandatory disclosure in the prescribed format

and display up-to-date information on its official website.

16. The institution shall make available the list of students admitted on its official

website.

17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render

itself vulnerable to adverse action including withdrawal of recognition by the Southern

Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
