WHEREAS, the recognition was granted to the institution namely, Susheela College of Education, Survey no. 5, Rachanapalli Village, Bellary Road, Anantapur, Andhra Pradesh-515001 run by St. Mark Educational Institution, Anantapur, Andhra Pradesh vide SRC vide order no. F.SRO/NCTE/B.Ed./2007-2008/12527 dt. 04.10.2007 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting **B.Ed.** programme of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.
- **3. AND WHEREAS,** the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue First SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 09.09.2020. The institution did not submit reply to Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 388th meeting held on 14th & 15th September 2020 considered the matter and decided to issue FSCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. In respect of RPRO. On perusal of the records, it is found that the institution has not submitted the following documents/information. Accordingly, a Final Show Cause Notice was issued to the institution on 22.02.2021. The institution has submitted reply on 13.04.2021.
- **5. AND WHEREAS,** the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the FSCN reply matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 13.04.2021. The Committee observed the reply submitted by the institution and found the following deficiencies:-

- 1. The instituting has submitted notarized photocopy site plan and building plan in which area of classroom, multipurpose hall etc. are not readable.
- 2. The institution has submitted notarized photocopy of Building Completion Certificate but not approved by competent authority.

- 3. The institution has submitted faculty approval letter dated 28.06.2017, the institution has not appointed 1 Perspective of Education, 1 Health & Physical Education and 1 Performing Arts.
- 4. The institution has submitted photocopy of FDRs, the institution has not submitted copy of "Form A" issued by the respective Bank Manager

Hence, the Committee decided to withdraw the recognition granted to Susheela College of Education, Survey No. 5, Rachanapalli Village, Bellary Road, Anantapur-515001, Andhra Pradesh for conducting B.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Susheela College of Education, Survey No. 5, Rachanapalli Village, Bellary Road, Anantapur-515001, Andhra Pradesh run by St. Mark Educational Institution, Anantapur, Andhra Pradesh 515001 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2021-2022 onwards.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
