## TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, **Bharthi College of Diploma in Education**, No. 28/1063-182, Saibaba Nagar, Nadyala, Kurnool District, Andhra Pradesh-518503 run by Sree Saila Educational Society, Kurnool Disrict, Andhra Pradesh-518503 vide SRC vide order no. F.SRO/NCTE//D.Ed./2008/6008 dt. 10.10.2008 for conducting (**D.Ed.**) course of two years duration with an annual intake of 50 students.

- 2. **AND WHEREAS**, the SRC in its 386<sup>th</sup> meeting held on 23<sup>rd</sup>-24<sup>th</sup> July 2020 considered the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 29.09.2020. The institution has submitted reply on 22.10.2020.
- **3. AND WHEREAS,** the SRC in its 402<sup>nd</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> September, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- 1. The Committee in its 386<sup>th</sup> meeting after perusal of the letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188 Pvt.D.El.Ed. colleges in A.P. since the said managements of Pvt.D.El.Ed. colleges have made admissions into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders. Accordingly, the SRC decided to issue a Show Cause Notice to all such institutions asking therein to explain about the observations made by the School Education Department, Govt. of Andhra Pradesh vide letter No. R.C.No. 359/A/SCERT/2019 dated 29.6.2020.
- 2. In view of the above decision a Show Cause Notice dated 29.09.2020 was issued to the institution. The institution has submitted its reply on 26.10.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.
  - (i) The Committee perused the letter No. RC No. 359/A/SCERT/2019 dated 29.06.2020 received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. colleges in A.P. since the said managements of Pvt. D.El.Ed. Colleges have made admission into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders.
  - (ii) The institution has submitted notarized photocopy of Building Plan in which Multipurpose Hall is not sufficient and not approved by Competent Authority.
  - (iii) The institution has not submitted notarized photocopy of Building Completion Certificate in prescribed format.

- (iv) The institution has not submitted a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund.
- (v) The institution has not submitted an Affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition and its present status giving following details
  - (a) Details of land & building available at the time of recognition with the Institution
  - (b) Details of land & building now available with the Institution
  - (c) Status of Management at the time of recognition and its present status

Hence, the Committee decided to withdraw the recognition granted to Bharathi College of Diploma in Education, No.28/1063-182, Saibaba Nagar, Nandyala, Kurnool District-518503, Andhra Pradesh for conducting D.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Bharathi College of Diploma in Education, No.28/1063-182, Saibaba Nagar, Nandyala, Kurnool District-518503, Andhra Pradesh run by Sree Saila Educational Society, Kurnool District, Andhra Pradesh-518503 for conducting (D.Ed) course of two years duration with an annual intake of 50 students with effect from the academic session i.e., 2021-2022 onwards.
- **5.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
