#### WITHDRAWAL ORDER

WHEREAS, The recognition was granted to the institution namely, Century Foundation Teacher Training Institute, No. 629/2B1, Rackiya Palayam, Vijayapuram, Nallur, Tirupur, Coimbatore District, Tamilnadu-641606 run by Century Foundation Educational Trust, Tirupur District, Tamilnadu for D.T.Ed & D.T.Ed-Al programme as per following details:-

- (i) The SRC vide Order No. F.SRO/NCTE/D.T.Ed./2006-2007/9179 dt. 13.11.2006 for conducting Elementary (D.T.Ed.) course of two-year duration with an annual intake of 50 students.
- (ii) The SRC vide order No. F.SRO/NCTE/D.T.Ed.-Al/2006-2007/16869 dt. 11.01.2008 for conducting D.T.Ed.-Al. course of two-year duration with an annual intake of 100 (Hundred) students which includes the existing intake of 50 and an additional intake of 50 students.
- 2. AND WHEREAS, the institution vide letter dated 23.08.2021 submitted written representation request to close the D.T.Ed & D.T.Ed-Al. Programme. The SRC in its 402<sup>nd</sup> meeting held on 13<sup>th</sup> & 14<sup>th</sup> September, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee agreed to close down the institution as requested by the institution vide dated 23.08.2021 by withdrawing the recognition granted to Century Foundation Teacher Training Institute, No. 629/2B1, Rackiya Palayam, Vijayapuram, Nallur, Tirupur, Coimbatore District – 641606, Tamilnadu for conducting D.T.Ed. alongwith additional intake Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

3. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Century Foundation Teacher Training Institute, No. 629/2B1, Rackiya Palayam, Vijayapuram, Nallur, Tirupur, Coimbatore District – 641606, Tamilnadu run by Century Foundation Educational Trust, Tirupur District, Tamilnadu for conducting D.T.Ed. & D.T.Ed.-Al programme of two years duration with an annual intake of 50 students & 50 students with effect from the next academic session i.e. 2021-2022 onwards.

**4.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

5. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
