WHEREAS, the recognition was granted to the institution namely, Sruthi College of Elementary Teacher Education, No. 113/4, Surapuram Village, Nidadavole Post & Taluk, West Godavari District. Andhra Pradesh-534301 run by Maddala Educational Society. No. 13-13-29, Gandhi Nagar 3rd Line, Nidadavole Village, Post & Taluk, West Godavari District, Andhra Pradesh-534301 for D.El.Ed & D.El.Ed-Al programme as per following details:-

- The SRC vide Order No. F.SRCAPP843/D.EI.Ed./AP/2012/45696 dt. 31.08.2012 (i) for conducting D.El.Ed. course of two-year duration with an annual intake of 50 students from the academic session 2012-2013.
- The SRC vide order No. F.SRO/NCTE/SRCAPP3512/D.El.Ed.-Al/AP/2016-(ii) 2017/84203 dt. 13.04.2016 for conducting D.El.Ed.-Al. programme of two-year duration with an annual intake of 50 students (1 unit) from the academic sessions 2016-2017.
- 2. AND WHEREAS, a letter No. RC. No. 359/A/SCERT/2019 dated 29.06.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for de-recognition order in respect of 188 Pvt. D.El.Ed Colleges in A.P. since the said managements of Pvt. D.El.Ed Colleges have made admission into the D.El.Ed Course during academic year 2018-19 on their own in violation of Government orders.
- AND WHEREAS, the matter was considered by SRC in its 386th meeting held on 23rd-24th July 2020 considered the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 29,09,2020. The institution did not submit reply to Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 402nd Meeting of SRC held on 13th & 14th September 2021 and considered the matter as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Show Cause Notice (SCN) on 29.09.2020. The institution failed to submit reply to the Show Cause Notice.

Hence, the Committee decided to withdraw the recognition granted to Sruthi College of Elementary Teacher Education, No.113/4, Surapuram Street, Village & Post, Nidadavoe Taluk & City, West Godavari District-534301, Andhra Pradesh for conducting D.El.Ed. alongwith additional intake programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sruthi College of Elementary Teacher Education, No.113/4, Surapuram Street, Village & Post, Nidadavoe Taluk & City, West Godavari District-534301, Andhra Pradesh run by Maddala Educational Society, No. 13-13-29, Gandhi Nagar 3rd Line, Nidadavole Village, Post & Taluk, West Godavari District, Andhra Pradesh-534301 for conducting two years duration with an annual intake of 50 students for (D.El.Ed.) & (D.El.Ed.-Al) course with effect from the academic session i.e. 2021-2022 onwards.
- **6.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
