WHEREAS, the recognition was granted to the institution namely, System College of Elementary Teacher Education, Khasara No. 224-1, 223-18, 223-19, Plot NO. 224-1, Ponduru Village, Post and Taluk, Srikakulam District, Andhra Pradesh-532168 run by System Educational Society, Plot No. 224-1, Ponduru Village, Post and Taluk, District, Andhra Pradesh-532168 vide SRC vide order no. F. Srikakulam SRO/NCTE/SRCAPP1507/D.EI.Ed./AP/2015/62236 dt. 03.03.2015 for (D.EI.Ed) programme of two years duration with an annual intake of 50 students (1 unit) from the academic sessions 2015-2016.

AND WHEREAS the institution vide letter dated 15.03.2021 submitted written representation request to close the D.El.Ed. Programme. The SRC in its 402<sup>nd</sup> meeting held on 13th & 14th September, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee agreed to close down the institution as requested by the institution on 23.02.2021 by withdrawing the recognition granted to System College of Elementary Teacher Education, Khasara No. 224-1, 223-18, 223-19, Plot No. 224-1, Ponduru Village, Post and Taluk, Srikakulam District-532168, Andhra Pradesh for conducting D.EI.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

- NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to System College of Elementary Teacher Education, Khasara No. 224-1, 223-18, 223-19, Plot No. 224-1, Ponduru Village, Post and Taluk, Srikakulam District-532168, Andhra Pradesh run by System Educational Society, Plot No. 224-1, Ponduru Village, Post and Taluk, Srikakulam District, Andhra Pradesh-532168 for conducting (D.El.Ed) programme of two years duration with an annual intake of 50 students (1 unit) with effect from the academic session i.e., 2021-2022 onwards.
- 4. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an
