WHEREAS, the recognition was granted to the institution namely, Sharada College of Education, Mahabubnagar Village, Post, Taluk & City, Mahbubnagar District – 509001, Telangana vide SRC vide order no. F.SRO/NCTE/SRCAPP2458/M.Ed./TS/2016-2017/84074 dated 12.04.2016 for (M.Ed.) programme of two-year duration with an annual intake of 50 students from the academic session 2016-2017.

- 2. AND WHEREAS, the SRC in its 399th Meeting held on 15th 16th June 2021 considered the matter and decided to issue last reminder (Letter). Accordingly, as per decision of SRC a last reminder letter was issued to the institution on 02.07.2021. The institution did not submitted reply to the last reminder letter.
- 3. AND WHEREAS, the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Last Reminder (Letter) on 02.07.2021. The institution failed to submit reply to the Last Reminder (Letter).

Hence, the Committee decided to withdraw the recognition granted to Sharada College of Education, Mahabubnagar Revenue Division, Sheshadrinagar, Mahabubnagar District – 509001, Telangana for conducting B.Ed. & M.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sharada College of Education, Mahabubnagar Village, Post, Taluk & City, Mahbubnagar District 509001, Telangana for conducting M.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2021-2022 onwards.
- 5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be
