CONTINUATION ORDER

WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely **Sree Narayana College of Education, Mahe-673310, Pondicherry** run by **Sree Narayana Educational Guidance Society, Mahe-673310, Pondicherry** for conducting B.Ed. & B.Ed. (Additional Intake) Programme are as follows:-

- (i) The SRC (NCTE) Order No. F.PN/B.Ed./NEW/01/SRO/NCTE/2000-2001/6716 dated 14.06.2001 for conducting B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2000-2001.
- (ii) The SRC (NCTE) Order No.F.N.P.N/SE-AI/SRO/NCTE/2004-2005/349 dated 31.01.2005 for conducting B.Ed. (Additional Intake) Course of one year duration with an annual intake of 120 students including existing intake of 100 students and an additional intake of 20 students from the academic session 2004-2005.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 30.01.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 30.05.2015 for conducting **B.Ed.(Additional Intake) Programme(APS03926)** of two years duration with an annual intake of 100 students of two basic units from the academic session 2015-16.

3. **AND WHEREAS**, the SRC 381st Meeting held on 31st October -01st November, 2019 and 387th meeting held on 24th -25th August,2020 decided that a SCN be issued in all such matters which have not complied with the conditions mentioned in the RPRO. Accordingly, as per the decision of SRC Show Cause Notice was issued on 10.09.2020. The institution submitted its reply on 15.10.2020.

4. **AND WHEREAS**, the SRC in its 392nd meeting held on 15th -16th December 2020 and Committee decided to constitute the **Visiting Team for shifting of premises** for infrastructure & instructional facilities etc. Accordingly, VT constitute on 23.12.2020. The VT was conducted on 18.01.2021 & 19.01.2021 and submitted its report on 27.01.2021.

5. **AND WHEREAS**, the SRC in its 426th Meeting held on 23rd June, 2023 has considered the matter and decided to issue a last reminder Letter to the institution. Accordingly, as per the decision of SRC last reminder Letter was issued to the

institution dt. 03.07.2023. The institution vide dated 14.07.2023 has submitted a reply to last reminder Letter.

6. **AND WHEREAS**, the SRC in its 427th meeting held on 20th July 2023 has considered the matter and decided to issue a last Reminder letter. Accordingly, as per the decision of SRC, a last reminder letter was issued to the institution on 01.08.2023. The institution has submitted a reply to the last reminder letter through Electronic Mail dated 10.08.2023.

7. **AND WHEREAS**, the SRC in its 428th meeting held on 25th August 2023 has considered the matter and decided as under: -

“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

*The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Sree Narayana College of Education, Mahe-673310, Pondicherry** for **B.Ed. programme for 2 basic units of 50 students each”**.*

8. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Sree Narayana College of Education, Mahe-673310, Pondicherry** for continuation of recognition for **B.Ed. Programme** for two-years duration with an annual intake of **2 basic units of 50 students each** subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.



10. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

13. The institution shall make available the list of students admitted on its official website.

14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the




Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
