WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Labour India Educational Society Teachers Training College, Marangattupilly P.O. Kottayam District, Kerala-686635 vide order no. F.KL/SEC/N/217/SRO/NCTE/2004-2005/765 dated 23.02.2005 for Secondary course of one year duration from the academic session 2004-2005 with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 20.01.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 20.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 Students (one basic unit) from the academic session 2015-16.
- AND WHEREAS, the institution has submitted reply of RPRO vide letter dt. 24.07.2015 3. along with documents received by this office on 05.08.2015.
- AND WHEREAS, the SRC in its 315th Meeting held during 17th & 18th June, 2016 has considered the reply to RPRO and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution dt. 07.06.2016. The institution has submitted reply of Show Cause Notice vide letter on 08.08.2016.
- AND WHEREAS, the SRC in its 324th Meeting held on 07th & 08th December, 2016 has considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution dt. 17.12.2016. The institution has submitted reply of Show Cause Notice vide letter dt. 30.01.2017.
- AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per decision taken in its 388th Meeting held on 14th & 15th September, 2020 and Sub-Committee of the SRC decided to issue Final Show Cause Notice to the institution where reply has not been submitted by the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution dt. 22.02.2021 & 10.03.2021.
- 7. AND WHEREAS, the Mahatma Gandhi University has submitted a letter dt. 29.03.2021 for approval of Faculty staff list approved by Registrar, Mahatma Gandhi University.
- AND WHEREAS, the institution has submitted a written representation regarding Final Show Cause Notice vide letter dt. 15.11.2022 without any hard copies of documents.
- AND WHEREAS, the SRC in its 427th Meeting held on 20th July, 2023 has considered the matter and decided to issue last reminder (Letter) to the institution. Accordingly, as per the decision of SRC last reminder (Letter) was issued to the institution dt. 01.08.2023, The institution has submitted a reply of last reminder (Letter) vide letter dt. 14.08.2023.

10. AND WHEREAS, the SRC in its 428<sup>th</sup> Meeting held on 25<sup>th</sup> August, 2023 has considered the matterjand decided as under: -

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Labour India Educational Society Teachers Training, College, Survey No. 191/7, 191/5, 191/6, 43/3, 34/5, 17/3-1, 17/1, Ward No. 8, Marangattupilly P.O., Kottayam District, Kerala – 686635 for B.Ed. programme for 1 basic unit of 50 students."

- 11. NOW THEREFORE, this order is issued permitting the institution i.e., Labour India Educational Society Teachers Training, College, Survey No. 191/7, 191/5, 191/6, 43/3, 34/5, 17/3-1, 17/1, Ward No. 8, Marangattupilly P.O., Kottayam District, Kerala 686635 for Continuation of recognition for B.Ed. programme of two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 12. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 13. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:

- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 16. The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
