WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely Kalpataru College of Education, B.H. Road, Tirpur-572202, Tumkur District, Karnataka, run by Kalpataru Vidya Samsthe, Tiptur, Tumkur District, Karnataka vide order no. No.F.SRO/NCTE/B.Ed./2004-2005/8786 on 24.12.2004 for conducting (B.Ed.) course of one year duration from the academic session 2004-2005 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 03.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- **3. AND WHEREAS,** the SRC in its 375<sup>th</sup> meeting held on 13<sup>th</sup>-14<sup>th</sup> May 2019 has considered the matter and decided to issue a Show Cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 23.05.2019. The institution has not submitted any reply to the Show Cause Notice.
- **4. AND WHEREAS,** the SRC in its 411<sup>st</sup> Meeting held on 23<sup>rd</sup> -24<sup>th</sup> May, 2022 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 03.06.2022. The institution has submitted its reply on 13.06.2022.
- **5. AND WHEREAS**, the SRC in its 414th Meeting held on 26th& 27th September, 2022 (P-2869/Coors.) has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No. F.SRC/NCTE/APS01885/B.Ed./{KA}/2022/135893 was issued to the institution on 10.10.2022.
- **6. AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No. 89-268/E-283686/2022 Appeal/11<sup>th</sup> Meeting, 2022, APPLSRC202214489 dated 11.01.2023 rejects the appeal and confirmed withdrawal order dated 10.10.2022.
- 7. **AND WHEREAS**, the institution has filed Writ Petition before the Hon'ble High Court of Karnataka at Bengaluru bearing W.P No.7726 of 2023 titled Kalpataru College of Education vs. NCTE & others whereby the Hon'ble High Court vide order dt. 02.08.2023 has directed that:-
  - "7. Learned counsel for the respondents submits that respondent No.2 will reconsider the case of the petitioner afresh and pass an appropriate order.
  - 8. In view of submission of the learned counsel for respondent No.2, the impugned orders are set aside. The petitioner is permitted to file reply to the final show-cause notice, within 15 days from the date of receipt of this order. On submitting the reply, respondent No.1 is permitted to consider the reply submitted by the petitioner and provide an opportunity of hearing to the petitioner and pass

appropriate order in accordance with law, within one month from the date of receipt of a copy of reply."

- 8. AND WHEREAS, the institution has submitted reply of Final Show Cause Notice on 23.08.2023 on the direction of Hon'ble High Court of Delhi order dated 02.08.2023.
- 9. AND WHEREAS, the SRC in its 428<sup>th</sup> Meeting held on 25<sup>th</sup> August, 2023 considered the matter and decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

In Compliance of Hon'ble High Court of Karnataka order dated 02.08.2023, the requisite documents was submitted by the institution on 24.08.2023 and the Committee on the perusal of the documents submitted by the institution decided that Continuation order be issued to the institution Kalpataru College of Education, Survey No. 152, Kanchagatta Village, (B.H. Road), Tiptur-572202 Tumkur District, Karnataka for B.Ed. programme, 02 basic units of 50 students each.

- 10. NOW THEREFORE, this order is issued permitting the institution i.e. Kalpataru College of Education, Survey No. 152, Kanchagatta Village, (B.H. Road), Tiptur-572202 Tumkur District, Karnataka for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 12. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with

photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
